AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the Northwest Quarter of Section 7, Township 27 South, Range 2 East of the 6th P.M., and adjacent street right-of-way more fully described as follows:

Beginning at the point of intersection of the east line of Woodlawn Blvd., and the north line of Government Lot 2 in the Northwest Quarter of Section 7, Township 27 South, Range 2 East of the 6th P.M.; thence east along said north line to the east line of said Government Lot 2; thence south along said east line to a point five hundred sixty-two (562) feet north of the south line of said Northwest Quarter; thence east parallel to said south line to the east line of said Northwest Quarter; thence north along said east line to the south line of 21st Street; thence east along said south line to a point one thousand (1000) feet west of the east line of the Southeast Quarter of Section 6, Township 27 South, Range 2 East of the 6th P.M. extended from the north; thence north to the north line of 21st Street; thence west along said north line to the east line of Woodlawn Blvd.; thence south along said east line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 32-466, 32-540, 32-622, 32-623, 32-630, 32-653, 32-663, 32-677, 32-678, 32-679, 32-729, 32-730, 32-881, / 32-911 and 32-963 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or

Beginning at the point of intersection of the east line of Woodlawn Blvd., and the north line of Government Lot 2 in the Northwest Quarter of Section 7, Township 27 South, Range 2 East of the 6th P.M.; thence east along said north line to the east line of said Government Lot 2; thence south along said east line to a point five hundred sixty-two (562) feet north of the south line of said Northwest Quarter; thence east parallel to said south line to the east line of said Northwest Quarter; thence north along said east line to the south line of 21st Street; thence east along said south line to a point one thousand (1000) feet west of the east line of the Southeast Quarter of Section 6, Township 27 South, Range 2 East of the 6th P.M. extended from the north; thence north to the north line of 21st Street; thence west along said north line to the east line of Woodlawn Blvd.; thence south along said east line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 32-466, 32-540, 32-622, 32-623, 32-630, 32-653, 32-663, 32-677, 32-678, 32-679, 32-729, 32-730, 32-881, / 32-911 and 32-963 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or

construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

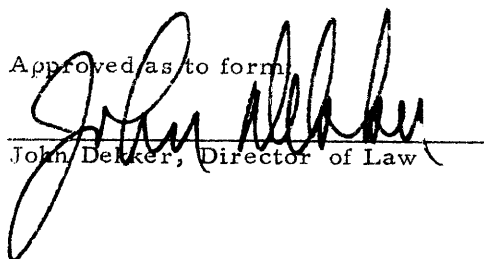
SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
