

ORDINANCE NO. 34-716

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having adopted a Resolution on August 24, 1976, indicating the City was considering annexation, and after having given notice in writing to all property owners, having published notice in The Daily Record, the official newspaper of Wichita; and after having held a public hearing and having prepared a plan for extension of services into the area to be annexed, all as required by law, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Part of the Southwest Quarter, Section 32, Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at the Northeast Corner of the Southwest Quarter, Section 32, Township 27 South, Range 2 East; thence south along the east line of said Southwest Quarter to the north line of Pawnee; thence west along said north line to the east line of Lot 7, Block 4, Cherry Creek Hills Addition extended from the north; thence northerly along said line to a point one hundred thirty-two and fifteen hundredths (132.15) feet more or less north of the south line of said Southwest Quarter; thence northeasterly parallel to and one hundred thirty (130) feet south of the south line of Parkmont Drive to the east line of White Cliff Lane, extended from the north; thence northerly along said line a distance of one hundred ninety-four (194) feet; thence with an angle to the right of ninety (90) degrees a distance of one hundred thirty-six and two tenths (136.2) feet; thence with an angle to the left of ninety (90) degrees a distance of one hundred seventy and seven tenths (170.7) feet; thence with an angle to the right of forty-three (43) degrees a distance of one hundred eight (108) feet; thence with an angle to the left of fifty (50) degrees, a distance of three hundred ten (310) feet to the Northeast Corner, Lot 5, Block 9, Cherry Creek Hills Addition; thence northeasterly to a point on the east line of Rosalie Lane extended from the north; thence northerly along said line a distance of one hundred seventy-nine (179) feet to the north line of Hildreth Lane extended from the west; thence easterly along said line extended a distance of one hundred twelve (112) feet; thence northerly parallel to and one

hundred twelve (112) feet easterly of the east line of Rosalie Lane to the south line of Cherry Creek Drive extended from the west; thence westerly along said line a distance of one hundred (112) feet; thence northerly along the east line of Rosalie Lane extended to the North line of Cherry Creek Drive; thence north parallel to the west line of Section 32 to the South line of the Northwest Quarter of said Section 32; thence east along said line to the point of beginning;

and,

Part of the Northeast Quarter, Section 32, Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

(PART I) Beginning at the Southwest Corner of the Northeast Quarter of Section 32, Township 27 South, Range 2 East; thence east along the south line of said Northeast Quarter to the west line of Webb Road; thence north along said west line to the north line of the South Half of the South Half of said Northeast Quarter; thence west along said north line to the west line of said Northeast Quarter; thence south along said west line to the point of beginning.

(PART II) Beginning at a point on the west line of Webb Road and the south line of the North Half of the Northeast Quarter, Section 32, Township 27 South, Range 2 East; thence west along the south line of the North Half of said Northeast Quarter to the east line of Cypress Drive extended southerly; thence northerly along said extended line and the east line of Cypress Drive to the south line of Harry Street; thence east along said south line to the west line of Webb Road; thence south along said west line to a point seven hundred sixty-eight (768) feet north of the Southeast Corner of the North Half of said Northeast Quarter; thence west parallel to the south line of said North Half to the west line of the east three hundred thirty (330) feet of said Northeast Quarter; thence south along said west line to a point one hundred thirty-two (132) feet north of the south line of the North Half of said Northeast Quarter; thence east parallel to the south line of said North Half to the west line of Webb Road; thence south along said west line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 34-239, 34-252, 34-253, 34-406, 34-414, 34-453, 34-141, 34-555, & 34-556, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.
