AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO. (A79-9)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the Northwest Quarter Section 5, Township 28 South, Range 2 East of the 6th P.M. and Southwest Quarter, Section 32, Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at a point forty (40) feet South and two hundred sixty-five (265) feet East of the Northwest Corner of the East half of said Northwest Quarter; thence South parallel to the east line of said Northwest Quarter for a distance of six hundred seventeen and five tenths (617.5) feet; thence West parallel to the north line of said Northwest Quarter for a distance of two hundred sixty-five (265) feet to the west line of the East half of said Northwest Quarter; thence South along said west line for a distance of five hundred sixty-nine and forty-four hundredths (569.44) feet; thence East parallel to the North line of said Northwest Quarter to the east line of said Northwest Quarter; thence North along said east line and the east line of the Southwest Quarter Section 32, Township 27 South, Range 2 East of the 6th P.M. to the north line of Pawnee Avenue; thence West along said north line to the Southeast Corner of Lot 7, Block 4, Cherry Creek Hills Addition; thence Southerly along the east line of said Lot 7 extended to the north line of the Northwest Quarter Section 5, Township 28 South, Range 2 East of the 6th P.M.; thence South parallel with the west line of said Northwest Quarter to a point one thousand eight hundred sixty-six and nine tenths (1866.9) feet east and forty (40) feet South of the Northwest Corner of said Northwest Quarter; thence West to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 35-871, 35-888, 35-917, 35-918, 35-938, 36-024, 36-058, + 36-071 be and the same

are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
