

ORDINANCE NO. 36-146

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO. 479-10

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and blought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in the Southeast Quarter of
Section 13, Township 28 South, Range 1 West
of the 6th P.M., more fully described as fol-
lows:

Beginning at a point on the West Line of Meridian
Avenue, said point being fifty (50.0) feet West
of the Northeast corner of said Southeast Quarter;
thence West along the North Line of said Southeast
Quarter, to the Northwest corner of said Southeast
Quarter; thence South along the West Line of said
Southeast Quarter to the South Line of the North
Half of said Southeast Quarter; thence East along
said South Line to the West Line of Meridian
Avenue; thence North along the West Line of
Meridian Avenue to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 35-871, 35-885,
35-917, 35-918, 35-938, 36-024, 36-058, 36-071, 36-101, 36-112
be and the same are hereby declared to constitute the lands within
the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance
shall be held or determined to be illegal, ultra vires or void
the same shall not be held or construed to alter, change or annul
any terms or provisions hereof which may be legal or lawful. And
in the event this ordinance in its entirety shall be held to be
ultra vires, illegal or void, then in such event the boundaries
and limits of said city shall be held to be those heretofore
established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
