

ORDINANCE NO. 36-579

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in the Southwest Quarter of
Section 28, Township 27 South, Range 2 East of
the 6th P.M., and the Southeast Quarter of
Section 29, Township 27 South, Range 2 East
of the 6th P.M., more fully described as fol-
lows:

Beginning at a point on the West line of Webb
Road, said point being eight hundred eighty-
five (885) feet North of the South line of
Section 29, Township 27 South, Range 2 East
of the 6th P.M.; thence East parallel to the
South line of said Section 29 and the South
line of Section 28, Township 27 South, Range 2
East of the 6th P.M. to a point two thousand
(2,000) feet East of the West line of said
Section 28; thence North parallel to the West
line of said Section 28 for a distance of eight
hundred seventy (870) feet; thence West parallel
to the South line of said Section 28 to the West
line of Webb Road; thence South along said West
line to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 36-392, 36-399, 36-424,
36-425, 36-437, 36-438 be and the same are hereby declared to con-
stitute the lands within the corporate limits and boundaries
of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance
shall be held or determined to be illegal, ultra vires or void
the same shall not be held or construed to alter, change or annul
any terms or provisions hereof which may be legal or lawful. And
in the event this ordinance in its entirety shall be held to be
ultra vires, illegal or void, then in such event the boundaries

and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
