

ORDINANCE NO. 36-582

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 31, Township 27 South,
Range 1 West of the 6th P.M., more fully described
as follows:

Beginning at a point forty (40) feet North and six
hundred forty (640) feet, more or less, East of the
Southwest Corner of the East Half of the Northeast
Quarter of said Section 31; thence West parallel to
the South line of said Northeast Quarter to a point
thirty (30) feet West of the west line of the East
Half of said Northeast Quarter; thence South parallel
to said west line for a distance of forty (40) feet to
the north line of the South Half of said Section 31;
thence West along said north line to the west line of
the East Half of the Southwest Quarter of said Section
31; thence South along said west line to a point fifty
(50) feet North of the south line of said Section 31;
thence East parallel to said south line to a point
thirty (30) feet East of the east line of the West
Half of the Southeast Quarter of said Section 31;
thence North parallel to said east line to the north
line of the South Half of said Section 31; thence
East along said north line to a point six hundred forty
(640) feet, more or less, East of the Southwest Corner
of the East Half of the Northeast Quarter of said
Section 31; thence North for a distance of forty (40)
feet to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinance No. 36-392, 36-399, 36-424,
36-425, 36-437, 36-438, 36-579,
36-580, + 36-581
be and the same are hereby declared to constitute the lands
within the corporate limits and boundaries of the City of Wichita,
Kansas.

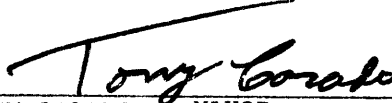
SECTION 3. That if any part or portion of this ordinance
shall be held or determined to be illegal, ultra vires or void

the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra, vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

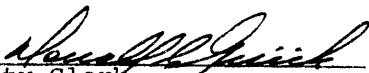
SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

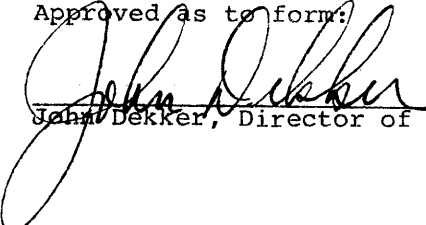
