

ORDINANCE NO. 36-612

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in the Southwest Quarter of
Section 7, and in the West Half of Section 18,
Township 27 South, Range 1 West of the 6th
P.M., more fully described as follows:

Beginning at a point thirty (30) feet North and
thirty (30) feet East of the Southwest Corner
of the Southwest Quarter of said Section 7;
thence South along a line lying thirty (30) feet
East of and parallel to the west line of said
Sections 7 and 18 to a point three hundred
sixty-seven (367) feet South of the north line
of the Southwest Quarter of said Section 18;
thence Easterly along a line parallel to the
north line of said Southwest Quarter for a
distance of two thousand two hundred seventy
(2,270) feet; thence Southerly, with a deflection
angle to the right of 91 degrees 11 minutes 32
seconds for a distance of seventy-four and three
tenths (74.3) feet; thence Southeasterly with a
deflection angle to the left of 77 degrees 00
minutes 00 seconds for a distance of one hundred
thirty-two (132) feet to a point on the east line
of said Southwest Quarter, said point being four
hundred seventy-five (475) feet South of the
north line of said Southwest Quarter; thence
Northerly along the east line of the West Half
of said Section 18 and the east line of the
Southwest Quarter of said Section 7, to a point
thirty (30) feet North of the south line of said
Section 7; thence Westerly parallel to and thirty
(30) feet North of said south line to the point
of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 36-392, 36-399, 36-424,
36-437, 36-438, 36-579, 36-580, 36-581, 36-582, 36-597,
be and the same are hereby declared
36-609, 36-610, + 36-611
to constitute the lands within the corporate limits and boundaries
of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

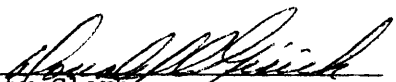

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

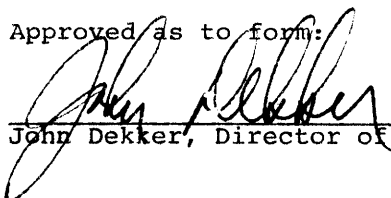
