

ORDINANCE NO. 36-695

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Sections 25 and 26, Township 26
South, Range 1 West of the 6th P.M., more fully des-
cribed as follows:

Beginning at the intersection of the west mean high
bank of the Arkansas River with the north line of
Section 25, Township 26 South, Range 1 West of the
6th P.M.; thence West along the north line of said
Section 25 to the east line of West Street; thence
South along said east line to the south line of
Forty-Fifth Street extended East; thence West
along said south line of Forty-Fifth Street to the
west line of the Northeast Quarter of Section 26,
Township 26 South, Range 1 West of the 6th P.M.;
thence South along said west line to the Northerly
right-of-way line of Kansas Highway 96; thence
Southeasterly along said right-of-way line to a
point seven hundred sixty-one and thirteen hundredths
(761.13) feet South and eighty-five and forty-nine
hundredths (85.49) feet West of the Southeast Corner
of the Northeast Quarter of Section 26, Township 26
South, Range 1 West of the 6th P.M.; thence North-
easterly and Northerly along said right-of-way line
to a point on the south line of said Northeast
Quarter, said point being thirty (30) feet West of
the Southeast Corner of said Northeast Quarter;
thence East along the south line of said Northeast
Quarter and the south line of the Northwest Quarter
of Section 25, Township 26 South, Range 1 West of
the 6th P.M. to the west mean high bank of the
Arkansas River; thence Northerly along said high
bank to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 36-392, 36-399,
36-424, 36-437, 36-438, 36-579, 36-580, 36-581, 36-582,
36-597, 36-609, 36-610, 36-611, 36-612, 36-669, +
36-677

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

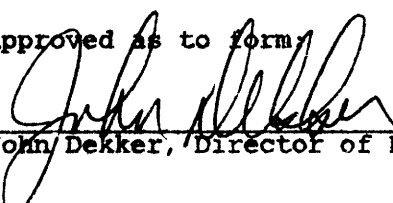
