

ORDINANCE NO. 36-938

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in Sections 35 and 36, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the intersection of the West Line of Oliver with the South Line of the North Half of the Southeast Quarter of said Section 35; thence North along said West Line of Oliver to a point one thousand nine hundred sixty-three (1,963) feet North of the South Line of said Section 35; thence East to the East Line of Oliver; thence North along said East Line of Oliver to a point seven hundred thirty-six (736) feet South of the North Line of said Section 35 extended East; thence West parallel to said extended North Line to a point three hundred ninety-seven (397) feet West of the East Line of said Section 35; thence North parallel to said East Line for a distance of two hundred ninety-six (296) feet; thence West parallel to the North Line of said Section 35 for a distance of three hundred (300) feet; thence South parallel to the East Line of said Section 35 for a distance of two hundred ninety-six (296) feet; thence West parallel to the North Line of said Section 35 for a distance of two hundred ninety-one and six tenths (291.6) feet; thence North parallel to the East Line of said Section 35 for a distance of one hundred ninety-nine and eighty-nine hundredths (199.89) feet; thence West parallel to the North Line of said Section 35 for a distance of two hundred eight and seventy-one hundredths (208.71) feet; thence North parallel to the East Line of said Section 35 to the South Line of 37th Street North; thence West along said South Line to a point five hundred twenty-nine and six tenths (529.6) feet East of the West Line of said Section 35; thence South parallel to said West Line to the South Line of the North Half of the Northwest Quarter of said Section 35; thence West along said South Line to the East Line of Hillside Avenue; thence South along said East Line of Hillside Avenue to the South Line of the North Half of the Southwest Quarter of said Section 35; thence East along said South Line and along the South Line of the North Half of the Southeast Quarter of said Section 35 to the point of beginning.

be and the same are hereby declared to constitute the lands

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
