

ORDINANCE NO. 36-971

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having adopted a resolution on November 4, 1980, indicating the City was considering annexation, and after having given notice in writing to all property owners, having published notice in The Daily Record, the official newspaper of Wichita; and after having held a public hearing and having prepared a plan for extension of services into the area to be annexed, all as required by law, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the Northeast Quarter of Section 8 and the Northwest Quarter of Section 9, in Township 27 South, Range 1 West of the 6th P.M., more fully described as follows:

Beginning at the Northwest Corner of Lot 1, Block 1, Westlink Village 16th Addition; thence South along the west line of said Lot 1 and said west line extended to a point on the north line of 19th Street North, said point being ten (10) feet South of the Southwest Corner of said Lot 1; thence West along the north line of 19th Street North for a distance of two hundred sixty-five (265) feet to the east line of Tyler Road; thence Southerly along a line parallel to and fifty (50) feet East of the west line of Section 9, Township 21 South, Range 1 West of the 6th P.M., for a distance of one hundred sixty-five (165) feet; thence Easterly to a point on the west line of said Westlink Village 16th Addition, said point being one hundred five (105) feet South of the Northwest Corner of Lot 1, Block 3 of said addition; thence Southerly along the westerly line of said addition to the north line of 17th Street North; thence West along said north line to the east line of Tyler Road; thence South along said east line to the north line of the South Half of Section 9, Township 27 South, Range 1 West of the 6th P.M.; thence West along said north line and the north line of the South Half of Section 8, Township 27 South, Range 1 West of the 6th P.M., to a point three hundred forty-nine (349) feet West of the Southeast Corner of the Northeast Quarter of said Section 8; thence North parallel to the east line of said Northeast Quarter for a distance of one hundred ninety-eight (198) feet; thence East parallel to the south line of said Northeast Quarter to the west line of Tyler Road;

thence North along said west line of Tyler Road to the north line of the South Half of the Northeast Quarter of said Section 8; thence East along said north line and the north line of the South Half of the Northwest Quarter of said Section 9 to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance No. 36-955 be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

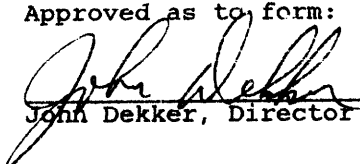
