ORDINANCE NO. 36-972*1st R
1-6-81*

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having adopted a resolution on November 4, 1980, indicating the City was considering annexation, and after having given notice in writing to all property owners, having published notice in The Daily Record, the official newspaper of Wichita; and after having held a public hearing and having prepared a plan for extension of services into the area to be annexed, all as required by law, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the South Half of Section 36, Township 26 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at a point on the north line of 29th Street North, said point being two hundred six and eight tenths (206.8) feet West of the west line of the Southeast Quarter of Section 36, Township 26 South, Range 1 East of the 6th P.M.; thence North parallel to said west line to a point eight hundred forty-one and five tenths (841.5) feet North of the south line of said Section 36; thence East parallel to the south line of said Section 36 for a distance of two hundred six and eight tenths (206.8) feet to the west line of said Southeast Quarter; thence North along said west line for a distance of one hundred twenty-eight and five tenths (128.5) feet; thence East parallel to the south line of said Section 36 for a distance of five hundred fifty (550) feet; thence South parallel to the west line of said Southeast Quarter to a point on the north line of 29th Street North, said point being five hundred fifty (550) feet East of the west line of said Southeast Quarter; thence West along the north line of 29th Street North to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 36-95 + 36-97| be and the same are hereby declared to constitute the lands

within the corporate limits and boundaries of the City of
Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

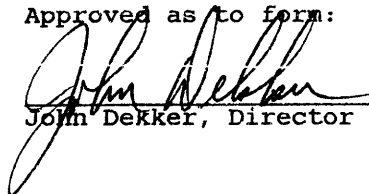
