BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in Sections 17 and 18, Township 27 South, Range 1 West of the 6th P.M. in Sedgwick County, Kansas, more fully described as follows:

Beginning at a point forty (40) feet West of the West Line of Section 17, Township 27 South, Range 1 West of the 6th P.M. and four hundred sixty-two (462) feet North of the extended South Line of the North Half of the Southwest Quarter of said Section 17; thence East parallel to said extended South Line to the West Line of Toh-N-Hah Trail; thence South along said West Line to the North Line of Toh-N-Hah Village; thence West along said North Line and said line extended to a point forty (40) feet West of the West Line of said Section 17; thence North parallel to and forty (40) feet West of said West Line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 37-615, 37-640, 37-641, 37-642, 37-643, 37-656, & 37-687

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries

and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

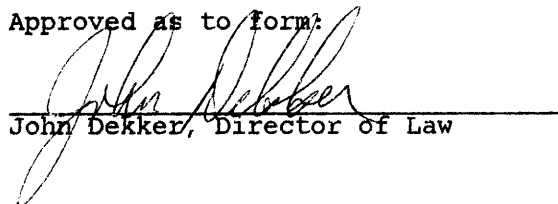
