

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having adopted a resolution on June 15,
1982, indicating the City was considering annexation, and after having
given notice in writing to all property owners, having published notice
in The Daily Record, the official newspaper of Wichita; and after having
held a public hearing and having prepared a plan for extension of ser-
vices into the area to be annexed, all as required by law, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 5, Township 28 South,
Range 2 East of the 6th P.M. in Sedgwick County,
Kansas, more fully described as follows:

Beginning at a point on the East Line of Rock Road,
forty (40) feet South of the North Line of the
Northwest Quarter, Section 5, Township 28 South,
Range 2 East of the 6th P.M.; thence East parallel
to said North Line to a point forty (40) feet South
and two hundred sixty-five (265) feet East of the
Northwest Corner of the East Half of said Northwest
Quarter; thence South parallel to the East Line of
said Northwest Quarter for a distance of six hundred
seventeen and five tenths (617.5) feet; thence West
parallel to the North Line of said Northwest Quarter
for a distance of two hundred sixty-five (265) feet
to the West Line of the East Half of said Northwest
Quarter; thence South along said West Line to the
North Line of the South Half of said Northwest
Quarter; thence West along said North Line to the
East Line of Rock Road; thence North along said
East Line to the point of beginning; except the fol-
lowing described parcel:

Beginning four hundred sixteen (416) feet East
and two hundred sixteen feet South of the North-
west Corner of said Northwest Quarter; thence
South forty-three (43) feet; thence East seventy-
five (75) feet; thence North fifty-five (55)
feet; thence West thirty-one (31) feet; thence
South twelve (12) feet; thence West forty-four
(44) feet to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 37-615, 37-640, 37-641,
37-642, 37-643, 37-686, 37-687, 37-877, 37-878, & 37-908

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

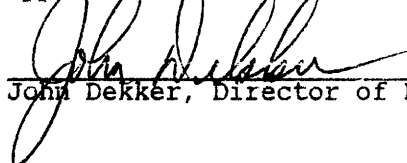
