AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in the Northwest Quarter of Section 31 and the Southwest Quarter of Section 30, Township 26 South, Range 2 East of the 6th P.M., in Sedgwick County, Kansas, more fully described as follows:

Beginning at the intersection of the North line of 37th Street North and the East line of Woodlawn; thence South along the East line of Woodlawn to a point two hundred (200) feet North of the South line of the North half of the Northwest Quarter of Section 31, Township 26 South, Range 2 East of the 6th P.M.; thence East parallel to said South line for a distance of six hundred three and four tenths (603.4) feet; thence South parallel with the East line of Woodlawn for a distance of two hundred (200) feet to the South line of said North half; thence East along said South line to the East line of said Northwest Quarter; thence North along said East line to a point three hundred seventy (370) feet South of the Northeast corner of said Northwest Quarter; thence West parallel with the North line of said Northwest Quarter for a distance of one hundred fifty (150) feet; thence North parallel with the East line of said Northwest Quarter to the North line of 37th Street North; thence West along the North line of 37th Street North to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 37-615, 37-640, 37-641, 37-642, 37-643, 37-646, 37-647, 37-877, 37-878, 37-908, 38-011, 38-012, 38-013, 38-014, 38-071, 38-072, 38-075, 38-079, 38-080, & 38-081

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

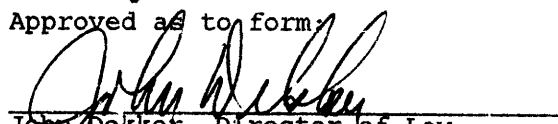
