

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 24, Township 27
South, Range 2 West of the 6th P.M., Sedgwick County,
Kansas, more fully described as follows:

Beginning at the Southeast Corner of the North-
west Quarter of said Section 24; thence west along the
south line of said Northwest Quarter to the east line
of Lot 5, Block 5, Rainbow Lakes West 4th Addition
to Sedgwick County, Kansas; thence northerly and
northwesterly along the east line of said Lot 5 and
the easterly line of Lots 1, 2, 3 and 4 of said
Block 5 to the east line of Lot 12, Block 2, Rainbow
Lakes West Addition to Sedgwick County, Kansas;
thence continuing northerly along said easterly
line to the north line of said Lot 12; thence
westerly along said north line and said line ex-
tended to the west line of Rainbow Lake Road;
thence northerly along said west line to the
northerly line of Saddle; thence southwesterly
along said northerly line to the northeast line
of Lot 16, Block 1, Rainbow Lakes West 4th Addition
to Sedgwick County, Kansas; thence northwesterly
and north along the northeast line and the east line
of said Block 1, of said addition to the south line
of Central Avenue; thence west along said south line
to the east line of 135th Street West; thence south
along said east line to the south line of Douglas
Avenue; thence east along said south line to the east
line of Angela; thence north and northeast along said
east line to the southwesterly line of Block 5,
Rainbow Lakes West 3rd Addition to Sedgwick County,
Kansas, thence southeast along said southwesterly
line to the north line of Maple Street; thence east
along said north line to the east line of the Southwest
Quarter of Section 24, Township 27 South, Range 2 West
of the 6th P.M., Sedgwick County, Kansas; thence north
along said east line to the point of beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within Section 1 of Ordinances No. 39-048, 39-077, 39-142
39-155, 39-167, 39-234 + 39-311 be and the same

are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

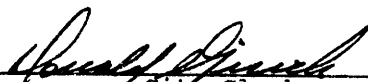

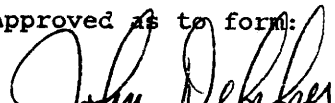
