

ORDINANCE NO. 39-899

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS, AND RELATING THERETO.

BE IT OKDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That, after having received a request from the owners of said property for annexation by the City, the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A tract of land in Section 12, Township 28 South, Range 1 West of the 6th P.M., Sedgwick County, Kansas, more fully described as follows:

Beginning at the intersection of the south line of Interstate 235 Highway and a line lying 1998.2 ft. east of and parallel to the west line of the Southwest Quarter of said Section 12; thence south parallel to said west line to a point 750 ft. north of the south line of said Southwest Quarter; thence east 150 ft.; thence south to the north line of MacArthur Road; thence east along said north line to a point 359.34 ft. west of the east line of said Southwest Quarter; thence north parallel to said east line to a point 359.34 ft. west and 610.4 ft. north of the Southeast corner of said Southwest Quarter; thence east 194.34 ft. to a point 610.4 ft. north and 165 ft. west

of said Southeast corner; thence north to a point 165 ft. west of and 1326 ft. north of said Southeast corner; thence east to the east line of said Southwest Quarter; thence north along said east line to the south line of Interstate 235 Highway; thence west along said south line to the point of beginning.


SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 39-728, 39-741, 39-764, 39-838, 39-839, 39-840, 39-852, 39-872, 39-873, 39-874, 39-877, & 39-895, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
