AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES
OF THE CITY OF WICHITA, KANSAS, AND RE-
LATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in Section 4 and 9, Township 27
South, Range 1 West of the 6th P.M., Sedgwick
County, Kansas, described as:

Beginning at the northwest corner of Lot 3,
Block A, Westwood Heights First Addition, said
point being on the south line of the north half
of the Northeast Quarter of Section 9, Township
27 South, Range 1 West; thence east along said
south line to a point 300 ft. west of the east
line of said Northeast Quarter, thence north
parallel to said east line for a distance of
904.55 ft.; thence east parallel to the north
line of said Northeast Quarter to the west
line of Ridge Road; thence north along said
west line 80 ft.; thence west parallel to the
north line of said Northeast Quarter to a
point 300 ft. west of the east line of said
Northeast Quarter; thence north parallel to
said east line and said line extended to the
north line of 21st Street North; thence west
along said north line to the east line of
Aldersgate Addition, extended north; thence

south along said extended east line and said east line to the south line of said Addition; thence west along said south line to the west line of the Northeast Quarter of said Section 9; thence south along said west line to the south line of the north half of said Northeast Quarter; thence east along said south line to the point of beginning.

SECTION 2. That the lands specified and included within Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinances No. 39-728, 39-741, 39-764, 39-838, 39-839, 39-840, 39-852, 39-872, 39-873, 39-874, 39-877, 39-895, 39-898, 39-899, 39-903, 39-913, 39-916, 39-967, & 39-968

be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

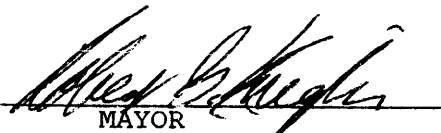
SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official

city paper.

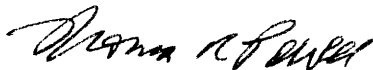
