ORDINANCE NO. 41-596

AN ORDINANCE INCLUDING AND INCORPORATING
CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS
OF LAND WITHIN THE LIMITS AND BOUNDARIES OF
THE CITY OF WICHITA, KANSAS, AND RELATING
THERE TO. (A91-12)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. That, after having received a request from the
owners of said property for annexation by the City, the following
blocks, parcels, pieces and tracts of land be and they are hereby
included and brought within the corporate limits of the City of
Wichita, Kansas:

A tract of land in the SW $\frac{1}{4}$, Section 5, Township 27 South,
Range 1 West of the 6th P.M., Sedgwick County, Kansas, de-
scribed as:

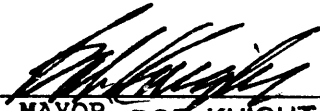
Beginning at the NW corner of Lot 1, Block A, Wichita Kennel
Club Addition; thence south along the west line of said
addition and said west line extended to the south line of
23rd Street North; thence east along said south line to the
east line of Crestline; thence north along said east line to
the north line of Wichita Kennel Club Addition extended
east; thence west along said north line to the point of
beginning.

SECTION 2. That the lands specified and included within
Section 1 of this ordinance, together with the lands specified
and included within the Resolution adopted December 18, 1990 and
Section 1 of Ordinances No. ^{41-315, 41-356, 41-421, 41-422, 41-482,}
^{41-488, 41-508, 41-509,} be and the same
^{41-518, 41-572, 41-573}
are hereby declared to constitute the lands within the corporate
limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-520, et seq.
