ORDINANCE NO. 25-910

AN OHDINANCE INCLUDING AND INCORPORATING CERTAIN TRACTS, BLOCKS, PARCELS, AND PIECES OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND BELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of Land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas;

A. Unplatted tracts in the Northwest Quarter of Section 28, Township 27 South, Range 2 East of the 6th P.M. and U.S. 54 right-of-way adjacent to the above unplatted tracts, more fully described as follows:

Beginning at the intersection of the north line of U.S. 54 right-of-way and the east line of Webb Road; thence south along the east line of Webb Road to the south line of the Kansas Turnpike; thence east along said right-of-way line to the east line of the west half of the Northwest Quarter of Section 28, Township 27 South, Range 2 East of the 6th P.M.; thence north along said line to the north line of U.S. 54; thence west to the point of beginning.

B. Unplatted tracts in the west half of Section 7, Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.
