AN ORDINANCE AUTHORIZING THE CONSTRUCTION OF LATERAL 39, SUBMAIN 2, SANITARY SEWER NO. 22, IN THE CITY OF WICHITA, KANSAS:

WHEREAS, by resolution duly adopted on the 13th day of June, 1961, the City Engineer of the City of Wichita was authorized and directed to prepare plans and specifications for the construction of a sanitary sewer more particularly described as follows:

Lateral 39, Submain 2, Sanitary Sewer No. 22

and cause an estimate of the cost to be filed with the City Clerk for the construction of said sewer; and.

WHEREAS, such plans, specifications and estimate of cost have been filed with the City Clerk as provided for hy resolution;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That it is hereby declared to be a public necessity to construct Lateral 39, Submain 2, Sanitary Sewer No. 22, in the City of Wichita.

SECTION 2. That the Mayor by and with the consent of the Board of Commissioners shall appoint three disinterested appraisers, who shall proceed to appraise such lots and pieces of land as shall be liable for said special improvements, being all of the lots and pieces of land in said sewer benefit district as described by Ordinance No. 25-901 and that the said appraisement shall be returned to this Commission at their first meeting after the same has been completed.

SECTION 3. This ordinance shall take effect and be in force from and after its passage and publication once in the official City paper.

ORDINANCE NO. 25-956

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRAJTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

A. Unplatted tracts in the Southwest Quarter of Section 17, the Southeast Quarter of Section 18, Section 19, and the Northwest Quarter of Section 20, all in Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the east line of Rock Road and the north line of the Southwest Quarter of Section 17; thence south along the east line of Rock Road to the south line of Cork Street; thence east along said south line to the west line of Dublin Street; thence south along said west line a distance of 238.05 feet; thence east to the east line of Dublin Street; thence southerly along the east line of Dublin and the west line of Second Addition to Vickridge to the south line of Central Avenue; thence east along the south line of Central Avenue; thence east along the south line of Central Avenue to the east line of the Northwest Quarter of Section 20; thence south along said east line to the north line of Douglas Avenue; thence west along the north line of Douglas Avenue to the west line of Rock Road; thence south along the west line of Rock Road to a point 300 feet north of the north line of Kellogg Street; thence west along a line parallel to and 300 feet north of the north line of Kellogg Street to the west line of the Southeast Quarter of Section 19: logg Street to the west line of the Southeast Quarter of Section 19 to the northeast Quarter of Section 19 to the northeast corner of Block E. Cresthill Manor; thence west 330 feet; thence north to the south line of Central Avenue; thence east along the south line of Central Avenue to the east line of Second Addition to Woodlawn Village extended from the north; thence north and northwesterly along the east line of said Addition to Chamberly along the east line of said Addition to the center line of Cresthill Road; thence northeasterly along a curve to the left having a central angle of 45 degrees and a radius of 357.3 feet a distance of 123.44 feet to point of tangency of said curve; thence on tangent to said curve 39 feet; thence with an angle to the left of 90 degrees for a distance of 149.96 feet to the point of curvature of a curve to the right having a central angle of 50 degrees and a radius of 343.12 feet; thence along said curve 299.43 feet to the point of tangency of said curve; thence north on tangent to said curve 117.4 feet, more or less, to the north line of the Southeast Quarter of Section 18; thence east along the north line of said Southeast Quarter and the north line of the Southwest Quarter of Section 17 to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordi nance, together with the lands specified and included within Section 1 of Ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, and 25-948, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra wires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 19 9 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
