SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-052

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Hummel Addition, Craig's Addition, and an unplatted tract in the Northeast Quarter of Section 10, Township 28 South, Range 1 East of the 6th P.M., and the Northwest Quarter of Section 11, Township 28 South, Range 1 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the south line of Craig's Addition and the east right-of-way line of Highway K-15; thence northwesterly along said right-of-way line to a line parallel to and six hundred eighty (680) feet south of the north line of Section 10, Township 28 South, Range 1 East of the 6th P.M.; thence east on said line to a point three hundred seventy-five (375) feet west of the east line of said Section 10; thence north to the south line of 31st Street South; thence east to the east line of said Section 10; thence south six hundred forty (640) feet; thence east to the east line of Hillside; thence south to the north line of Butler

Drive; thence east to the east line of Clifton Avenue; thence south to the south line of Craig's Addition extended from the west; thence west to the point of beginning.

SECTION 2. BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Washington Heights, an addition, and an unplatted tract in the west half of Section 1, Township 28 South, Range 1 East of the 6th P.M. all more fully described as follows:

Beginning at the intersection of the north line of 31st Street South and the east line of Oliver Avenue; thence north along said east line to the west line of George Washington Boulevard; thence southeasterly along said west line to the north line of New Jersey Drive (was Delaware Drive); thence east to the east line of George Washington Boulevard; thence southeasterly along said east line to the south
