ORDINANCE NO. 26-069

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

An unplatted tract in the Southwest Quarter of Section 27, Township 27 South, Range 1 West of the 6th P.M., and adjacent Railroad right-of-way, more fully described as follows:

Beginning at the intersection of the east line of the Southwest Quarter of Section 27 and the north right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence westerly along said right-of-way line to a point forty (40) feet west of the east line of said Southwest Quarter; thence north parallel to said east line to a point six hundred seventeen and eighty-five hundredths (617.85) feet south of the north line of said Southwest Quarter; thence west parallel to said north line a distance of two hundred sixty-three (263) feet; thence south parallel to the east line of said Southwest Quarter to the south right-of-way line of the Atchison, Topeka and Santa Fe Railroad; thence easterly along said right-of-way line to the east line of said Southwest Quarter; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, 26-023, 26-030, 26-031, 26-032, 26-033, 26-037, 26-038, 26-039, 26-040, 26-041, 26-042, 26-051, 26-052, 26-053, 26-054, 26-055, 26-056, 26-057, 26-058, 26-059, 26-060, 26-061, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the city of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-070

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

Beginning at the point of intersection of the east line of Woodlawn Avenue and the center line of Gypsum Creek; thence northerly and easterly following the meandering of the center line of Gypsum Creek to the east line of the west half of the Northwest Quarter of Section 31, Township 27 South, Range 2 East of the 6th P.M.; thence south to the north line of Kansas Turnpike; thence southwesterly along the north line of the Kansas Turnpike to the east line of Woodlawn; thence north to the point of beginning.
