#### ORDINANCE NO. 26-070

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the west half of Section 31, Township 27 South, Range 2 East of the 6th P.M., more fully described as follows:

Beginning at the point of intersection of the east line of Woodlawn Avenue and the center line of Gypsum Creek; thence northerly and easterly following the meandering of the center line of Gypsum Creek to the east line of the west half of the Northwest Quarter of Section 31, Township 27 South, Range 2 East of the 6th P.M.; thence south to the north line of Kansas Turnpike; thence southwesterly along the north line of the Kansas Turnpike to the east line of Woodlawn; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, 26-023, 26-030, 26-031, 26-032, 26-033, 26-037, 26-038, 26-039, 26-040, 26-041, 26-042, 26-051, 26-052, 26-053, 26-054, 26-055, 26-056, 26-057, 26-058, 26-059, 26-060, 26-061, 26-069, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

ORDINANCE NO. 26-071

AN ORDINANCE MAKING A SPECIAL ASSESSMENT TO PAY FOR  
THE COST OF ABATING CERTAIN PUBLIC HEALTH NUISANCES  
UNDER THE PROVISIONS OF SECTION 7.40.020 OF THE CODE  
OF THE CITY OF WICHITA.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF  
WICHITA, KANSAS:

SECTION 1. That the sums set opposite the following lots, pieces and parcels of land or ground, herein specified, be and the same are hereby levied to pay the cost of abating certain public health nuisances under the provisions of Section 7.40.020 of the Code of the City of Wichita, which public health nuisances were determined to have existed upon the following described property:

SECTION 2. The sum so assessed and apportioned against the several lots, pieces and parcels of land as hereinbefore set out and not paid within 30 days from date of notices sent out by the City Clerk as provided by law, shall be collected by special assessment upon the property liable therefore in one installment and placed upon the tax roll for the year 1962 and shall be certified to the County Clerk and shall be levied and collected in the same manner as other taxes, and the City Clerk is hereby directed to give written notice to property owners owning property assessed therein, as required by law.

SECTION 3. This ordinance shall take effect and be in force from and after its publication once in the official city paper.
