

ORDINANCE NO. 26-074

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts, Maple Lane Addition and street right-of-way in the Northeast Quarter of Section 27, Township 27 South, Range 1 West of the 6th P.M., more fully described as:

Beginning at the point of intersection of the east line of Maple Lane Addition and the center line of Maple Avenue; thence west to the west line of said Addition; thence south to the south line of the north 1 1/4 acres of the east 5 acres of the west 15 acres of the Northwest Quarter of the Northeast Quarter of said Section 27; thence west to the east line of the west half of the east 5 acres of the west 15 acres of the Northwest Quarter of the Northeast Quarter of said Section 27; thence south to the south line of the North half of the east 5 acres of the west 15 acres of the Northwest Quarter of the Northeast Quarter of said Section 27; thence west to the west line of the east 5 acres of the west 15 acres of the Northwest Quarter of the Northeast Quarter of said Section 27; thence north to the center line of Maple; thence west to a point 30 feet west of the east line of the west 5 acres of the Northwest Quarter of the Northeast Quarter of said Section 27; thence south to a point 30 feet west of the east line of the west 5 acres of the Northwest Quarter of the Northeast Quarter of said Section 27 and 30 feet north of the south line of North half of the Northeast Quarter of said Section 27; thence west to a point on the west line of the Northeast Quarter of said Section 27, 30 feet north of the south line of the North half of the Northeast Quarter of said Section 27; thence south to the south line of the North half of the Northeast Quarter of said Section 27; thence east to the east line of Maple Lane Addition; thence north to the point of beginning.

SECTION 2. That the lands specified and included in Section 1 of this ordinance, together with the lands specified and included within Section 1 of Ordinance Nos. 25-663, 25-678, 25-833, 25-878, 25-893, 25-910, 25-924, 25-939, 25-946, 25-947, 25-948, 25-956, 25-957, 25-958, 25-959, 25-960, 25-961, 25-981, 25-982, 25-983, 25-984, 25-985, 26-001, 26-002, 26-003, 26-004, 26-005, 26-006, 26-007, 26-008, 26-020, 26-021, 26-022, 26-023, 26-030, 26-031, 26-032, 26-033, 26-037, 26-038, 26-039, 26-040, 26-041, 26-042, 26-051, 26-052, 26-053, 26-054, 26-055, 26-056, 26-057, 26-058, 26-059, 26-060, 26-061, 26-069, 26-070, 26-073, be and the same are hereby declared to constitute the lands within the corporate limits and boundaries of the City of Wichita, Kansas.

SECTION 3. That if any part of portion of this ordinance shall be held or determined to be illegal, ultra vires or void, the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said city shall be held to be those heretofore established by law.

SECTION 4. That the City Attorney be and he is hereby instructed at the proper time to draw an ordinance re-defining the boundaries and limits of the City of Wichita, Kansas under and pursuant to G.S. 1959 Supp., 12-517 et seq.

SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.

ORDINANCE NO. 26-075

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

Unplatted tracts in the west half of Section 1, Township 28 South, Range 1 West of the 6th P.M. and adjacent street right-of-way more fully described as follows:

Beginning at the point of intersection of the west line of West Street and the westerly right-of-way line of the Missouri Pacific R.R.; thence northeasterly along said right-of-way line to the south line of Pawnee; thence east to the east line of the west half of said Section 1; thence south to the north line of 31st Street South; thence west to the east line of the Replat of Ridgeview 4th Addition; thence northerly and westerly following the east line and north line of said Replat to the north line of Ridgeview 5th Addition; thence westerly along the north line of Ridgeview 5th Addition and said north line extended to the west line of West Street; thence north to the point of beginning.

SECTION 2.
