ORDINANCE NO. 26-090

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERE'TO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tracts in the southwest Quarter of Section 1, Township 27 South, Range 1 East of the 6th P.M. more fully described as follows:

Beginning at the northeast corner of the southeast Quarter of said southwest Quarter; thence west to the northwest corner of the southwest Quarter of said southwest Quarter; thence south to the north line of 21st Street; thence east to the east line of said southwest Quarter; thence north to point of beginning.

SECTION 2. SECTION 5. This ordinance shall take effect and be in force from and after its passage and publication once in the official city paper.
