ORDINANCE NO. 26-091

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS AND RELATING THERETO.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS:

SECTION 1. That the following blocks, parcels, pieces and tracts of land be and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas:

- A. Unplatted tract in the southwest Quarter of Section 1, Township 27 South, Range 1 East of the 6th P.M. more fully described as follows:

Beginning at the northeast corner of the southwest Quarter of Section 1; thence west to the northwest corner of the northeast Quarter of said southwest Quarter; thence south to the southwest corner of the northeast Quarter of said southwest Quarter; thence east to the southeast corner of the northeast Quarter of said southwest Quarter; thence north to the point of beginning.

SECTION 2.
