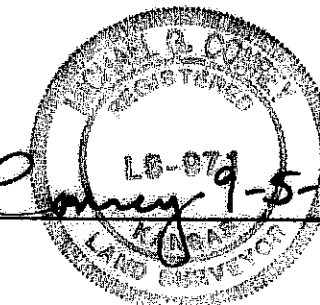

Know all men by these presents that we, the undersigned, have caused the land in the surveyors certificate to be platted into Lots, a Block, a Street, and Floodway Reserves to be known as "ROYSE ESTATES", Sedgwick County, Kansas. The riverbank maintenance easement is hereby granted to Sedgwick County, or to the appropriate governing body, for riverbank maintenance, flood control, and riverbank beautification. The street is hereby dedicated to and for the use of the public. Floodway Reserve "A" shall be owned and maintained by the owner of Lot 1, Block A. Floodway Reserve "B" shall be owned and maintained by the owner of Lot 2, Block A. Floodway Reserve "C" shall be owned and maintained by the owner of Lot 3, Block A. Floodway Reserve "D" shall be owned and maintained by the owner of Lot 4, Block A. The Floodway Reserves are hereby reserved for floodway purposes and shall be the responsibility of the aforementioned lots, respectively, until such time as Sedgwick County or the appropriate governing body elects to assume the responsibility for maintenance and improvements to the drainage. No buildings shall be constructed or placed on or within said floodway, nor shall any fill, change of grade, creation of channel, or any other work be carried on without the permission of the Engineer for Sedgwick County or the Engineer for the appropriate governing body. The Minimum Building Pad Elevations for the lowest opening to the structures shall be as indicated on the face of the plat.
