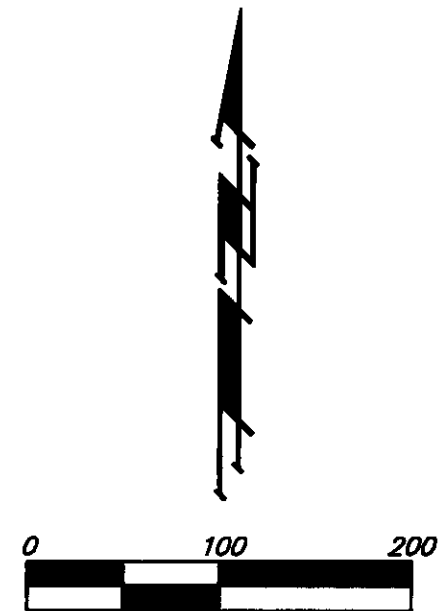
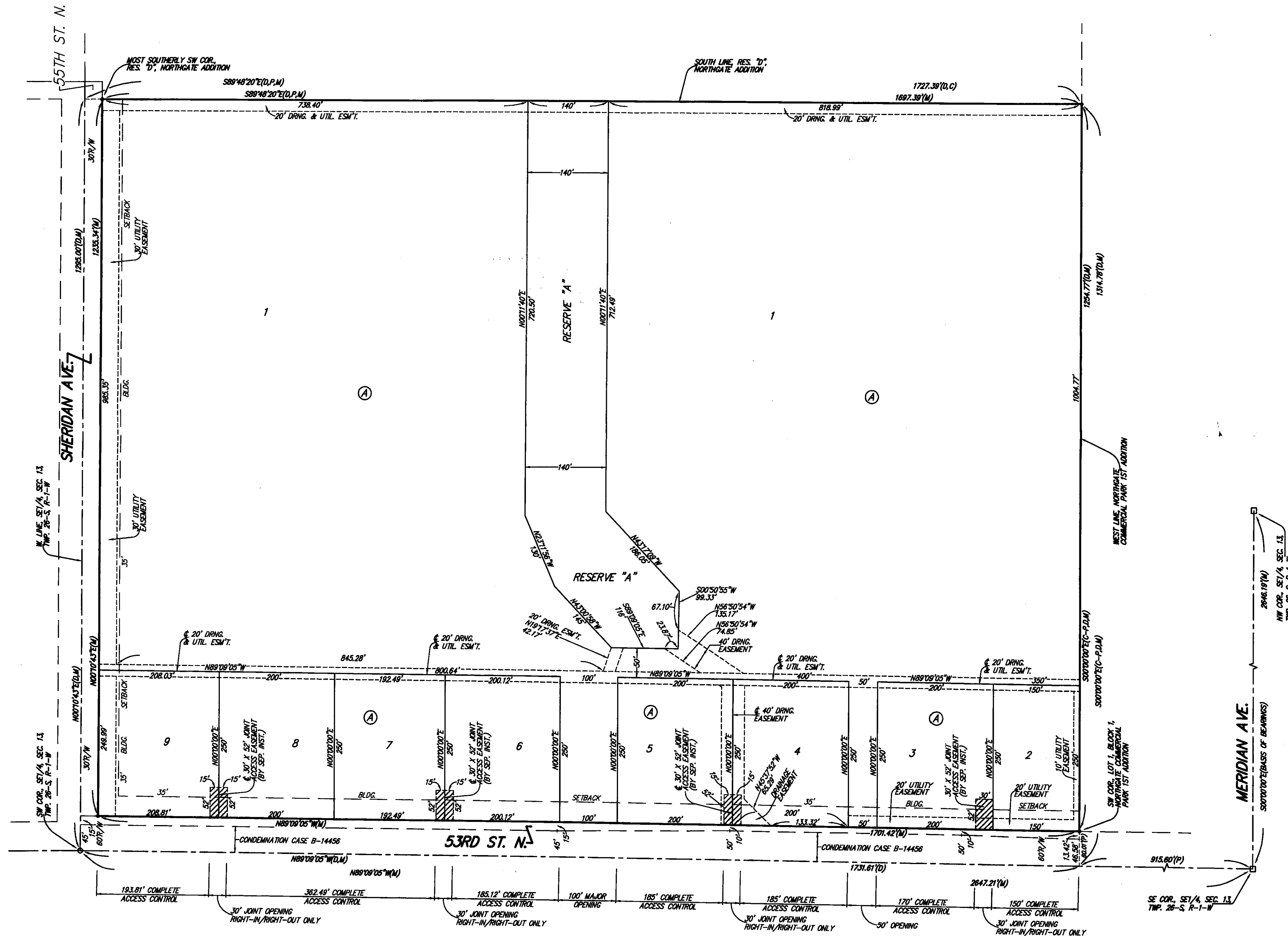

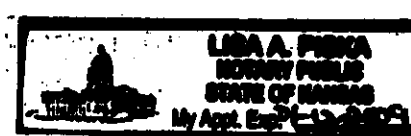

structures shall be as indicated on the face of the plat.

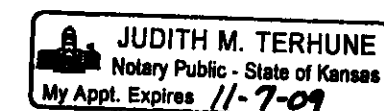

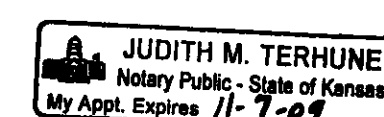
