

MATERIALS AND CONSTRUCTION UNDER THIS PROJECT SHALL CONFORM TO THE CITY OF WICHITA, DEPARTMENT OF ENGINEERING STANDARD SPECIFICATIONS, UNLESS OTHERWISE NOTED.

ALL NEW PAVEMENT AND GRAVEL SURFACING SHALL BE REGRADED TO MATCH EXISTING GRADES
ALL PAVEMENT SHALL BE REMOVED 12" (MINIMUM) BEYOND THE LIMITS OF EXCAVATION OR TO
AN EXISTING JOINT IF LESS THAN 4'-0" FROM EXCAVATION. EXISTING PAVEMENT SHALL BE
SAW CUT PARALLEL OR PERPENDICULAR TO EXISTING JOINTS UNLESS SHOWN OTHERWISE ON
PLANS. CONTRACTOR SHALL RECONSTRUCT PAVEMENT JOINTS TO MATCH EXISTING

ALL SACKFILL SHALL CONFORM TO THE CITY OF WICHITA, DEPARTMENT OF ENGINEERING
STANDARD SPECIFICATIONS FOR COMPACTED SELECT FILL PIPE SHALL BE REDDED IN
ACCORDANCE WITH CITY SPECIFICATIONS FOR COMPACTED GRANULAR MATERIAL.

CONTRACTOR SHALL VERIFY LOCATIONS OF ALL UTILITIES PRIOR TO CONSTRUCTION.
SHALL NOTIFY UTILITY COMPANIES PRIOR TO EXCAVATION AND SHALL BE RESPONSIBLE
FOR ANY REQUIRED UTILITY RELOCATIONS OR ADJUSTMENTS.

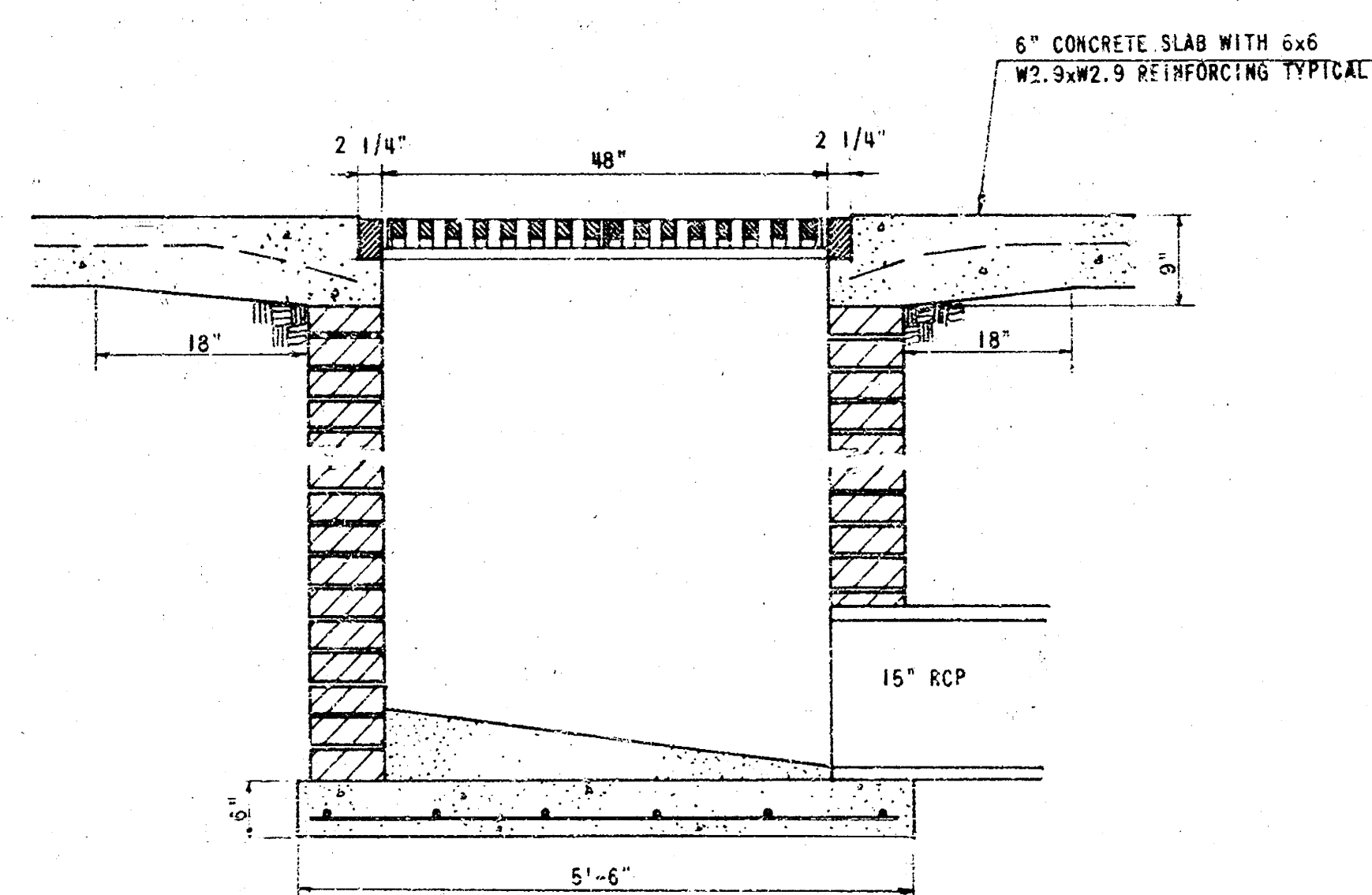
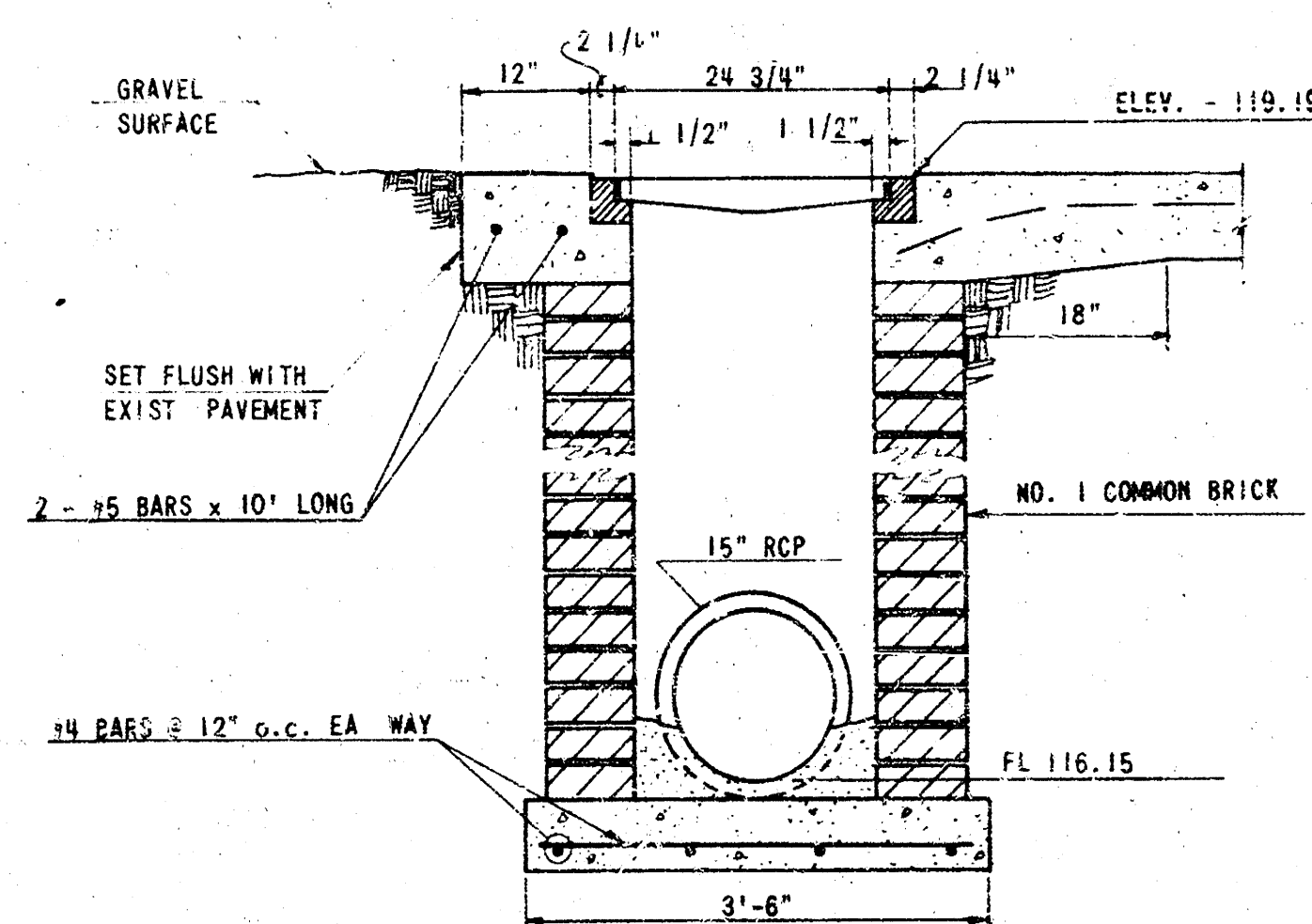
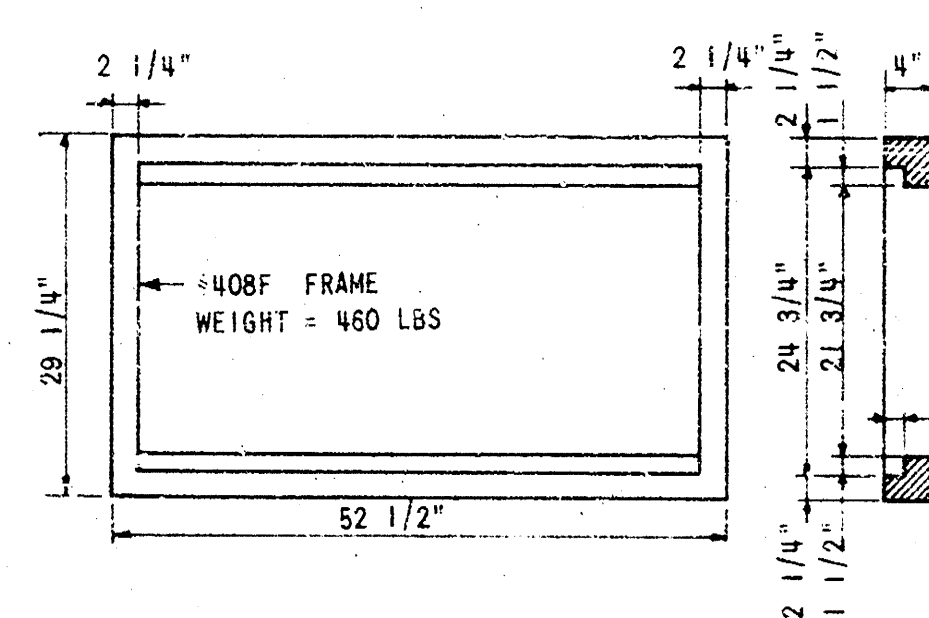
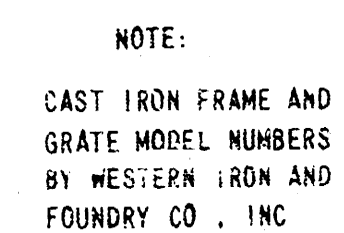
THE CONTRACTOR SHALL BE RESPONSIBLE FOR ALL CONSTRUCTION STAKING

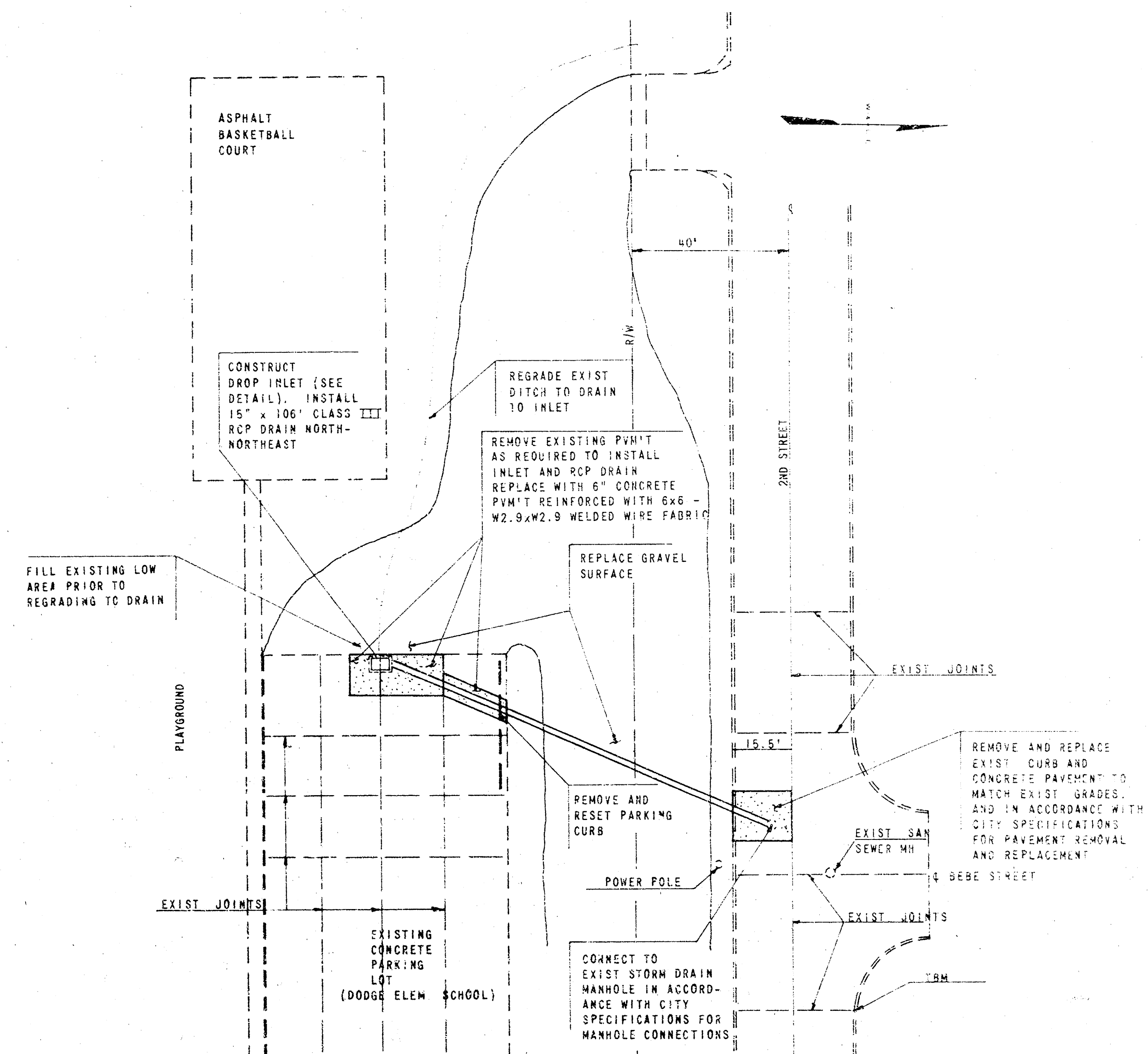

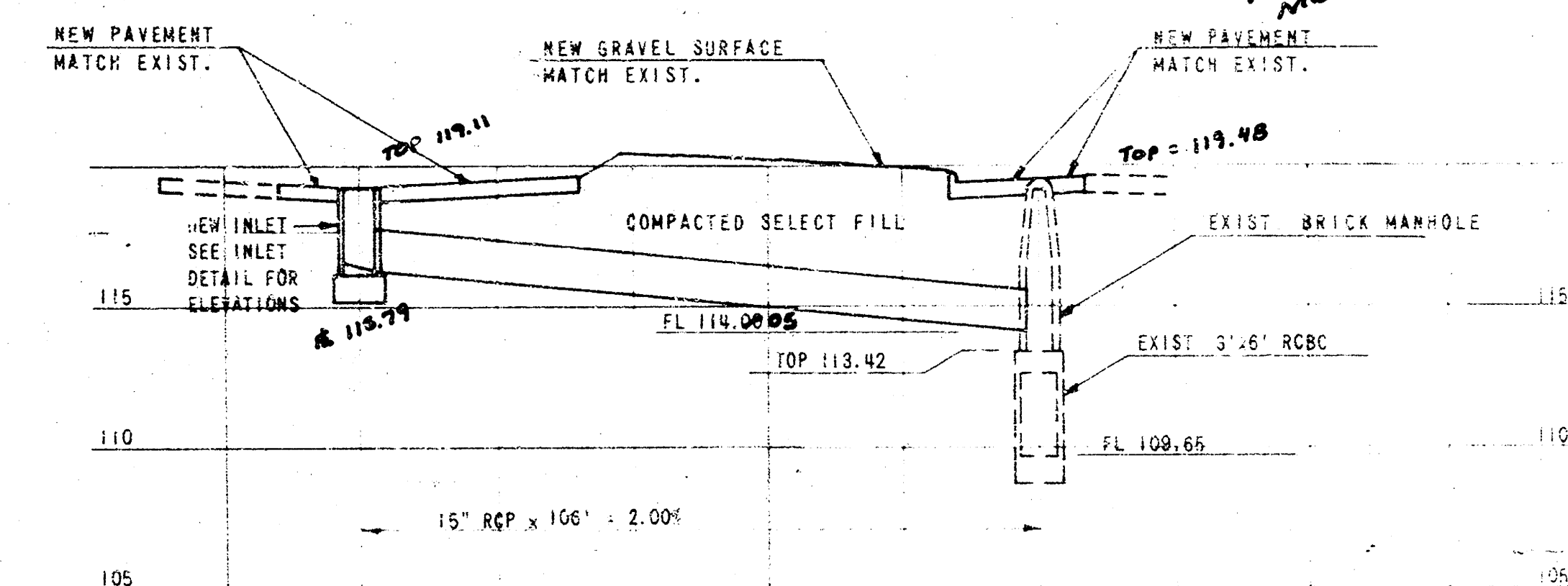
