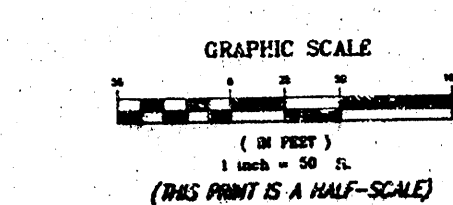
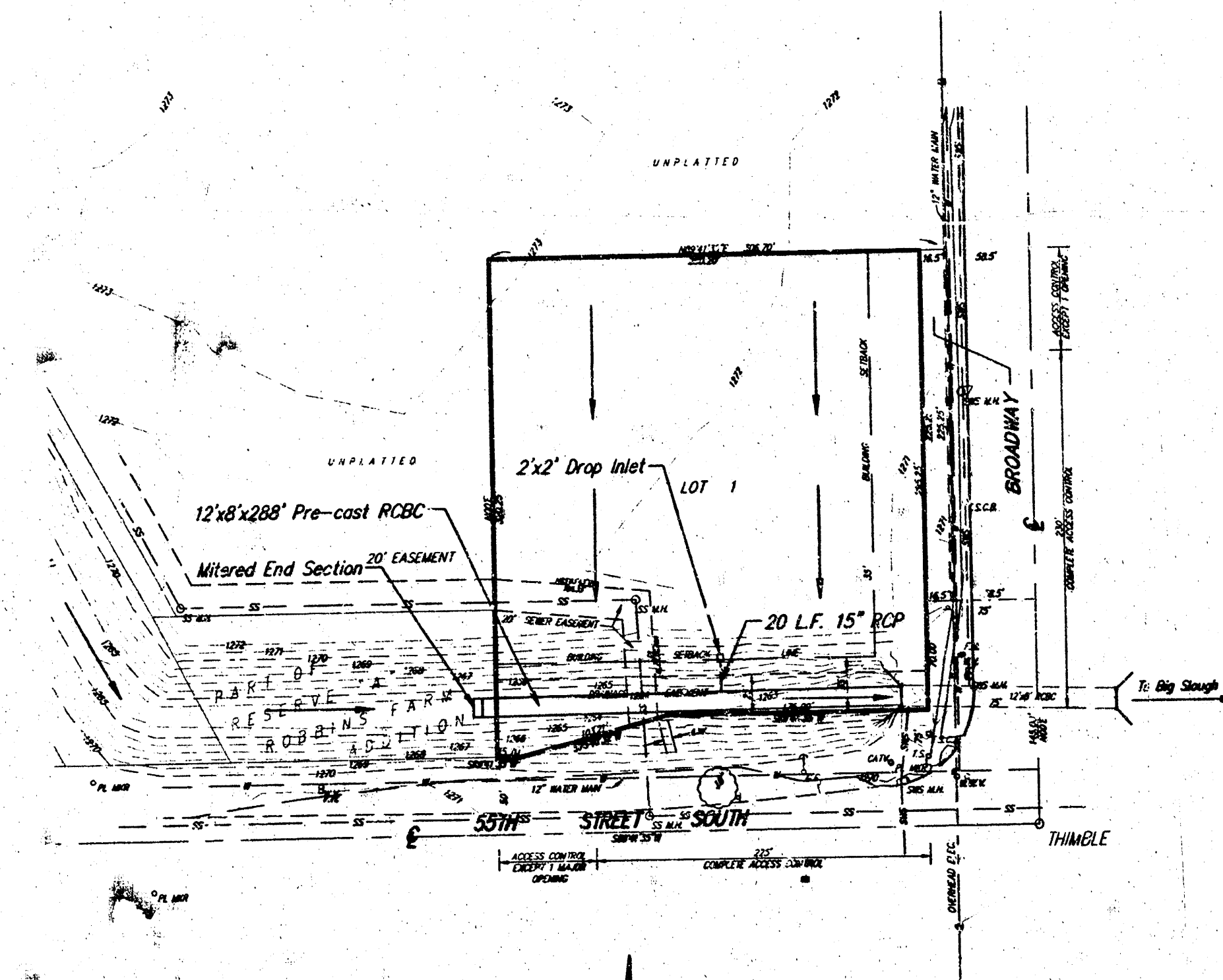

Corner of said Reserve A; thence S00°W along the east line of said Reserve A, 70 feet to the place of beginning, and

That part of the SE 1/4 of Sec. 20, Twp. 28-S, R-1-E of the 6th P.M., Sedgewick County, Kansas described as commencing at the S.E. Corner of said SE 1/4, thence N02°E along the east line of said SE 1/4, 143 feet; thence S89°41'32"W, 58.50 feet for a place of beginning; thence N02°E, 225.25 feet; thence S89°41'32"W, parallel with the south line of said SE 1/4, 336.70 feet; thence S00°W parallel with the east line of said SE 1/4, 155.25 feet to a point 145 feet north of the south line of said SE 1/4; thence N89°41'32"E, 306.70 feet to the place of beginning.
