Dear Mr. Reid:

Members of my staff have reviewed the signing plans of the K-96 project. Although our comments may be after bids have been taken, we think they should be brought to your attention.

- Sheet 9
1. There is a "Jct. 96" for southbound traffic, but not one for northbound, unless it is already existing.
 2. The eastbound off ramp shows only one Stop sign on the left side of the road and does not have any One-Way or Do Not Enter signing.
 3. We do not think the eastbound on-ramp needs any One-Way signing.
 4. We do not think three Wrong Way signs are necessary in this, or similar situations, for an off-ramp.

- Sheet 11
1. Has the exit numbering system changed? Will this exit now be number 12, and will all the other exit numbers be changed?

- Sheet 13
1. The One-Way signs for on-ramps 2 and 8 are not needed.
 2. We do not think three Wrong Way signs for ramps 1 and 6 are needed.
 3. The Do Not Enter signs on Meridian are not needed.

- Sheet 14
1. The Two Way traffic signs are not needed. They should be replaced with Right Lane Ends plus Width Transition signs.
 2. At the beginning of the median, the sign posts should have No U Turn signs on the back.
 3. The two Do Not Enter signs at 37th are not needed.

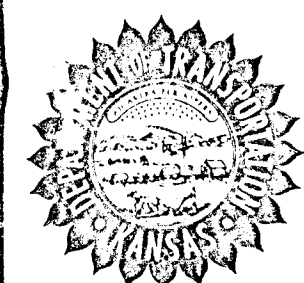
On all the sheets the unnecessary word message signs such as merge, keep right, etc., should be eliminated.

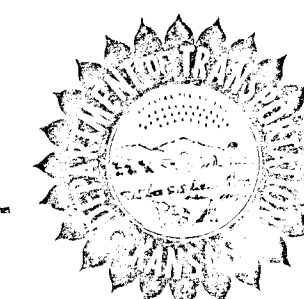
