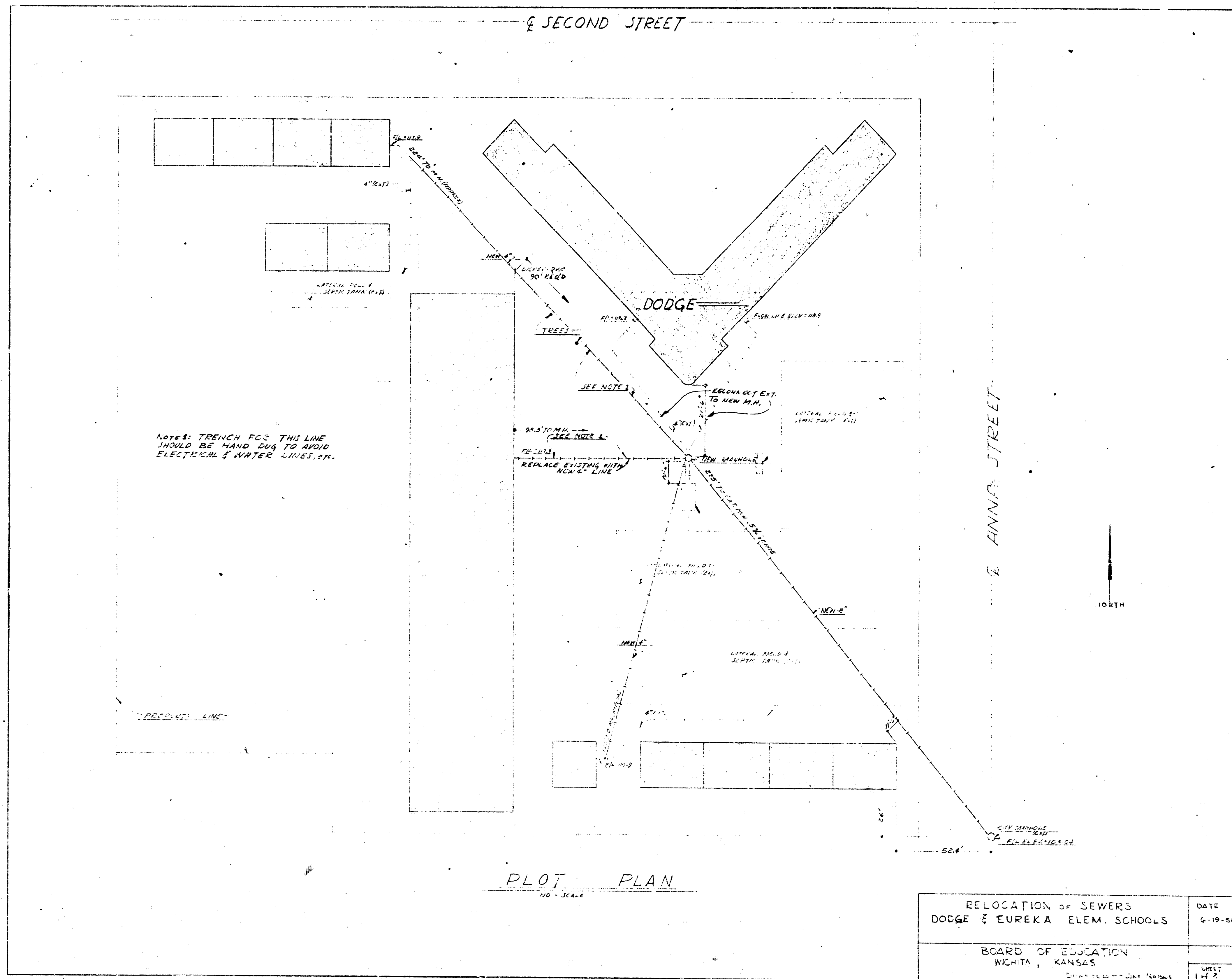




The Contractor shall furnish the required performance and statutory bonds and enter into a contract within ten (10) days after the award has been made. These specifications shall become a part of the contract.

A certified check or cashier's check equal to 5% of the bid, shall be required and shall accompany the bid.

The Contractor shall obtain and pay for all permits.

The installation shall be guaranteed for a period of one (1) year, from date of acceptance of the work, covering materials and workmanship.

Payment will be made in full within thirty (30) days after approval by Owner and final acceptance of the work.

SCOPE OF WORK

This contract shall include the furnishing of all material and labor required for the following:

Dodge

Building one new manhole, connecting three new 12" lines and two existing 12" lines to it, laying approximately 419 feet of 12" Vitrified Clay Pipe plus 90 feet of 12" Dickey P.V.C. 12" Vitrified Clay Pipe, laying approximately 275 feet of 8" Vitrified Clay Pipe and constructing drop inlet into city manhole.

Eureka

Laying approximately 16 feet of 8" Vitrified Clay Pipe from city manhole and terminating it with a "y" and observation hole, laying approximately 270 feet of 6" Vitrified Clay Pipe from the "y" to the building.

SPECIFICATIONS

All pipe shall be Vitrified Clay except for ninety (90) feet which shall be Dickey P.V.C. Vitrified Clay as noted on the plans.

This work shall be done under the supervision of and meet with the approval of the City Engineering Department of the City of Wichita.

The Contractor shall reimburse the City Engineering Department for any expenses incurred in connection with this work.

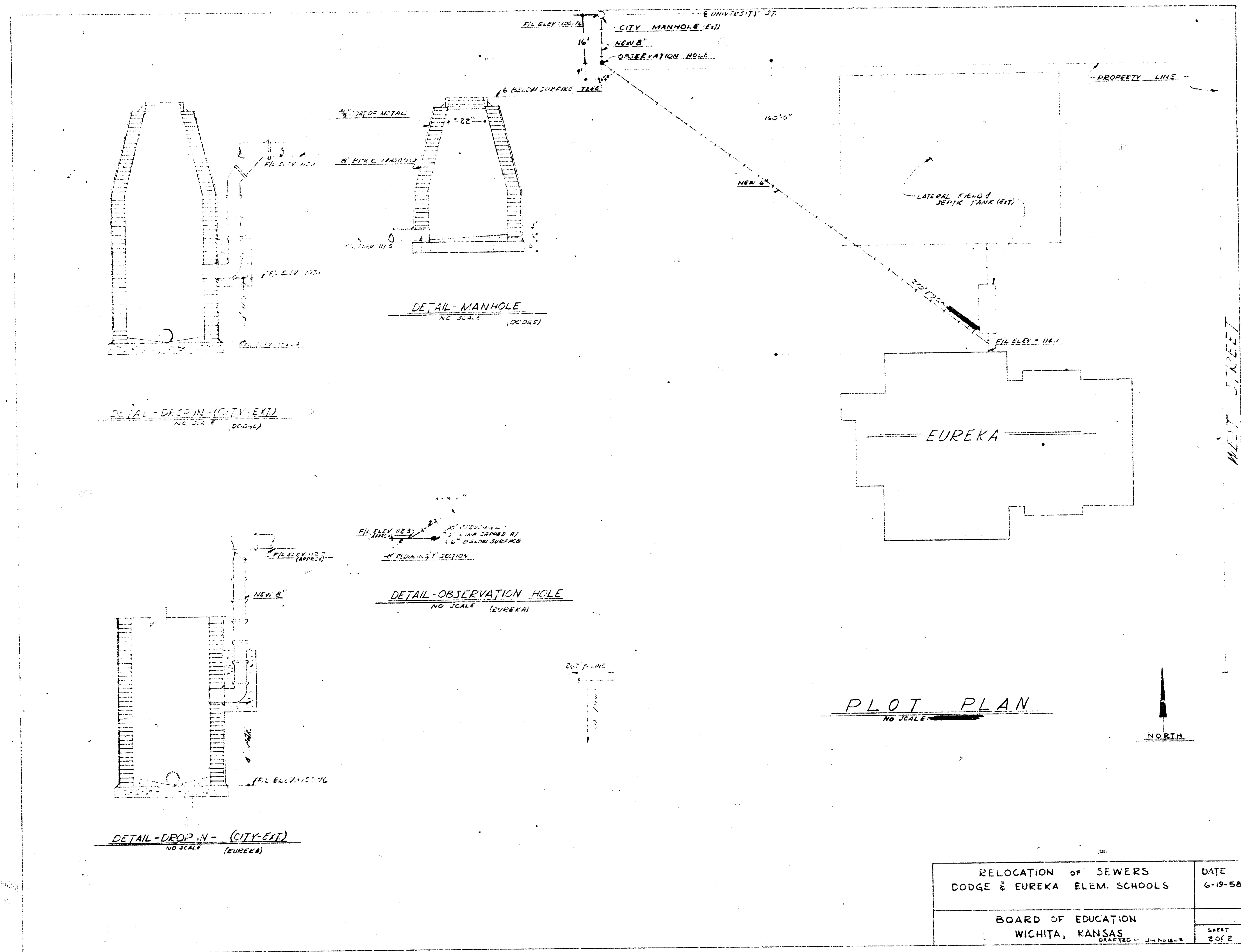
