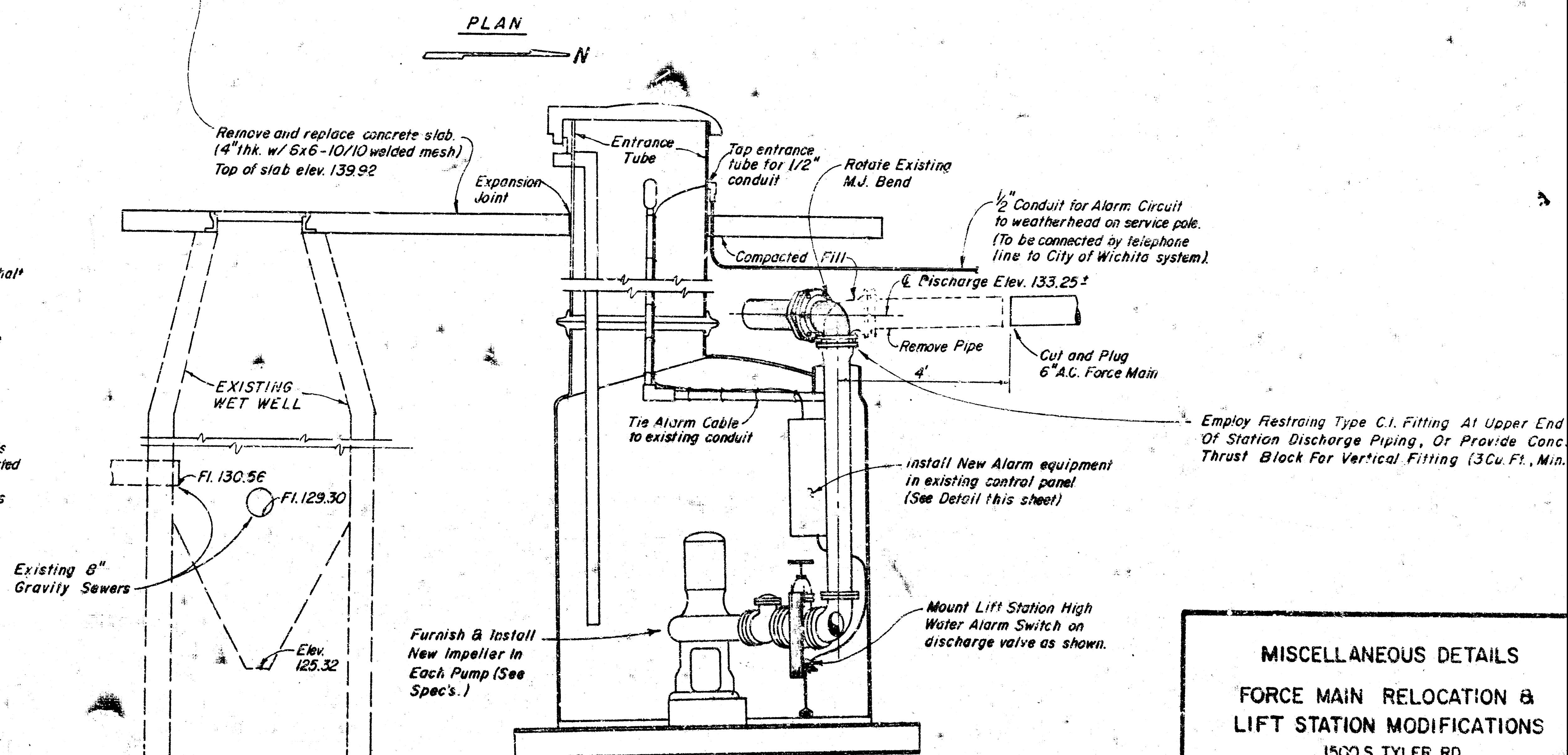


Furnish And Install Alarm circuit to City of Wichita alarm system (See note 1)

1. All joints of Cast Iron-to-PVC shall be Mechanical Joint with Sleeve and transition gasket for PVC pipe.
2. Alarm wiring shall be provided by contractor through weatherhead (8' above ground on service pole). Connection at service pole by telephone company.
