**REMOVAL NOTES:**

REMOVE ALL FENCING WITHIN ACQUIRED RIGHT OF WAY. REMOVE FENCING TO FIRST POST ON PRIVATE PROPERTY. RECONSTRUCT FENCE AND CONSTRUCT END POST (LIKE KIND AND TYPE) AT R/W LINE.

SEE "TRAFFIC CONTROL PLAN & CONSTRUCTION SEQUENCE" FOR ORDER OF REMOVAL. UTILITY RELOCATIONS MUST BE COMPLETED BEFORE PAVEMENT REMOVAL BEGINS.

THE DECISION TO REMOVE OR RETAIN THE LARGE TREES ALONG THE EAST SIDE OF OLIVER FROM STA. 16+00 TO STA. 18+00 SHALL BE MADE BY THE FIELD ENGINEER. THE SIDEWALK SHALL BE ADJUSTED TO ACCOMMODATE ANY TREES REMAINING.
