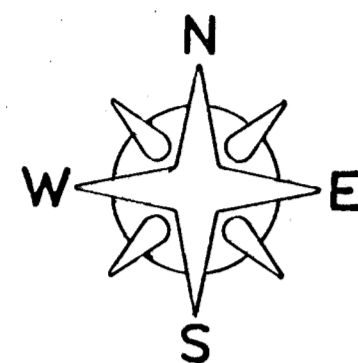
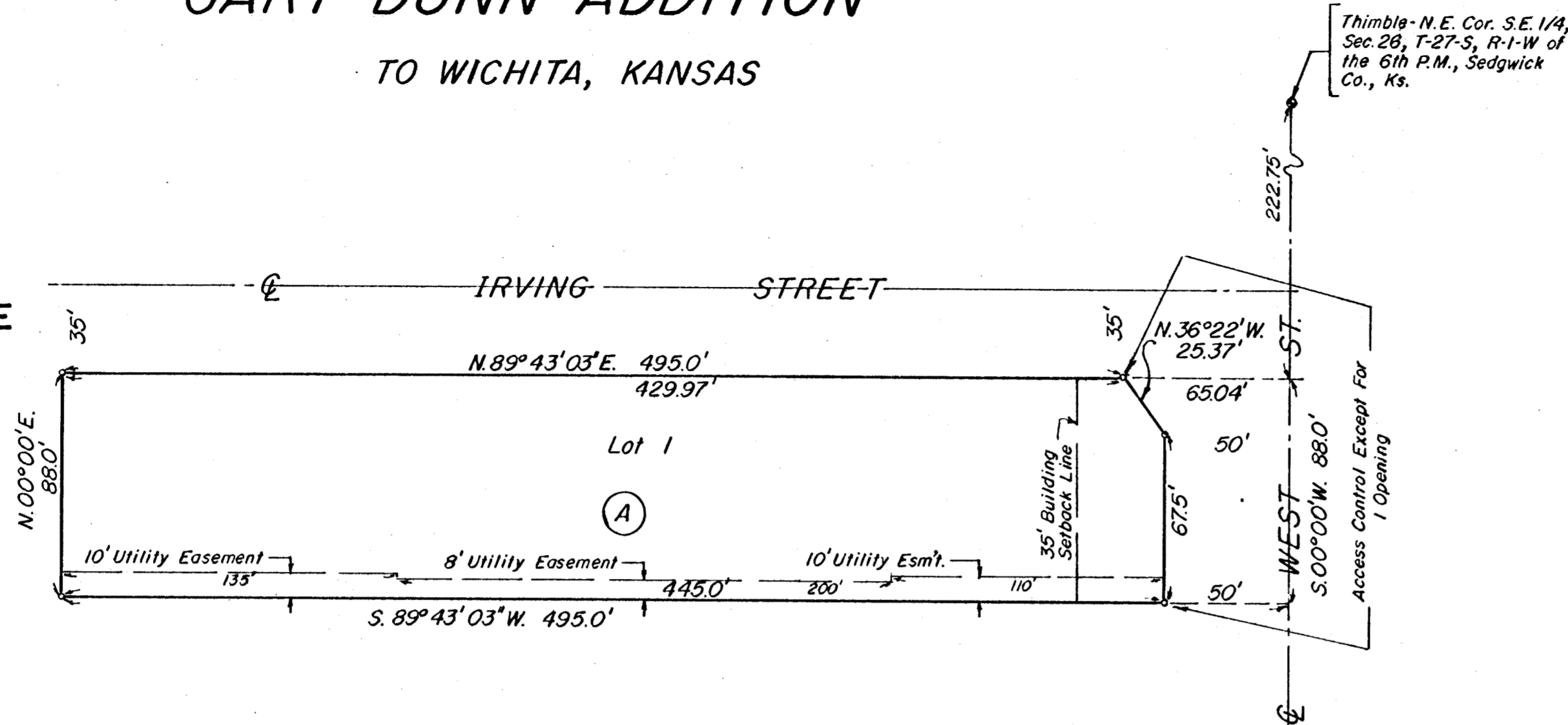


GARY DUNN ADDITION TO WICHITA, KANSAS

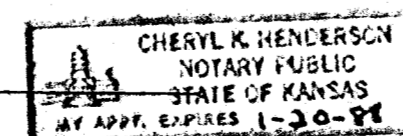
