


EDISON ACRES SEDGWICK COUNTY, KANSAS

Garber, Professional Surveyor #683, on April 17, 2024 as follows: Commencing at the Northeast corner of the Northwest Quarter of Section 20, Township 28 South, Range 3 West of the 6th Principal Meridian; THENCE with a bearing of South 01°05'13" East (basis of bearings is NAD 83 Kansas South Zone) along the East line of said Northwest Quarter a distance of 825.00 feet for the point of beginning; THENCE continuing South 01°05'13" East along the East line of said Northwest Quarter a distance of 1,026.16 feet; THENCE South 88°58'36" West parallel with the South line of said Northwest Quarter a distance of 848.41 feet; THENCE North 01°05'13" West parallel with the East line of said Northwest Quarter a distance of 1,027.66 feet to the South line of Shumard Oak Addition; THENCE North 89°04'55" East parallel with the North line of said Northwest Quarter along the South line of Shumard Oak Addition a distance of 848.41 feet to the point of beginning.
