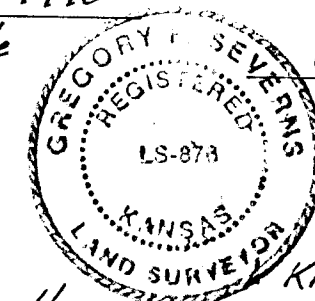


# CALIENDO 11TH ADDITION

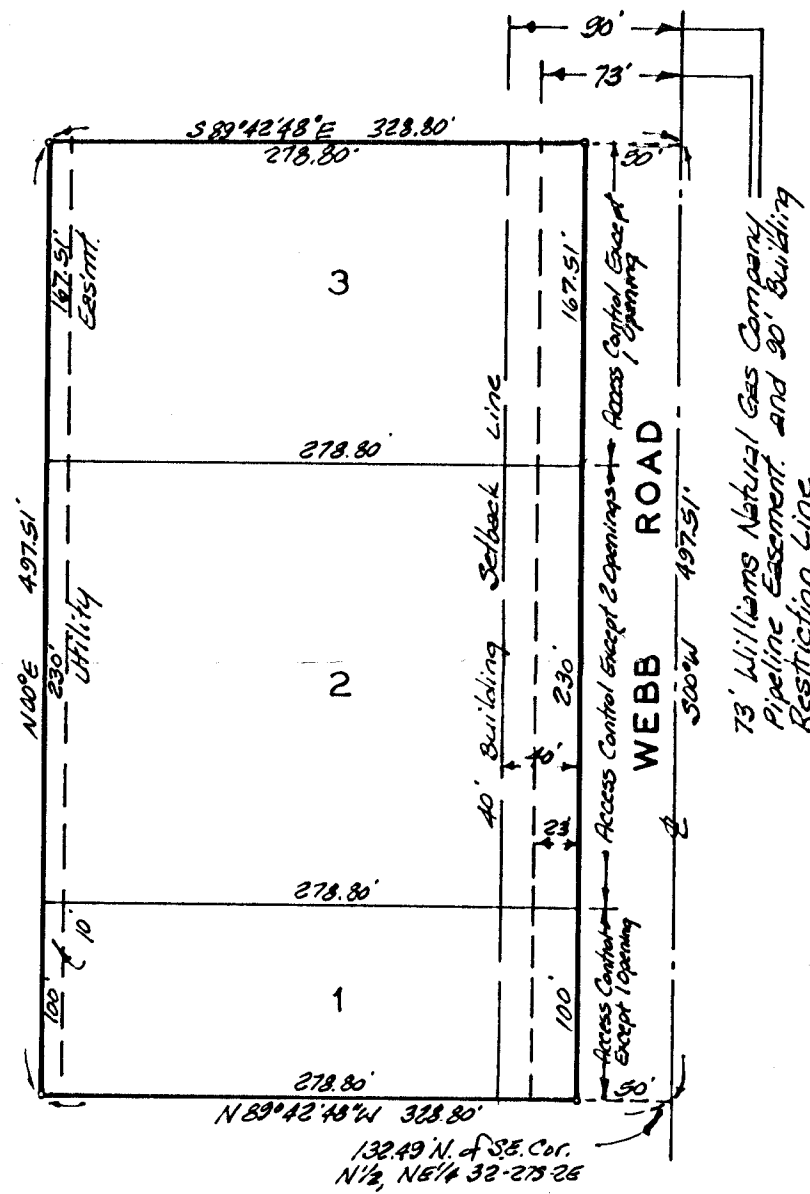
