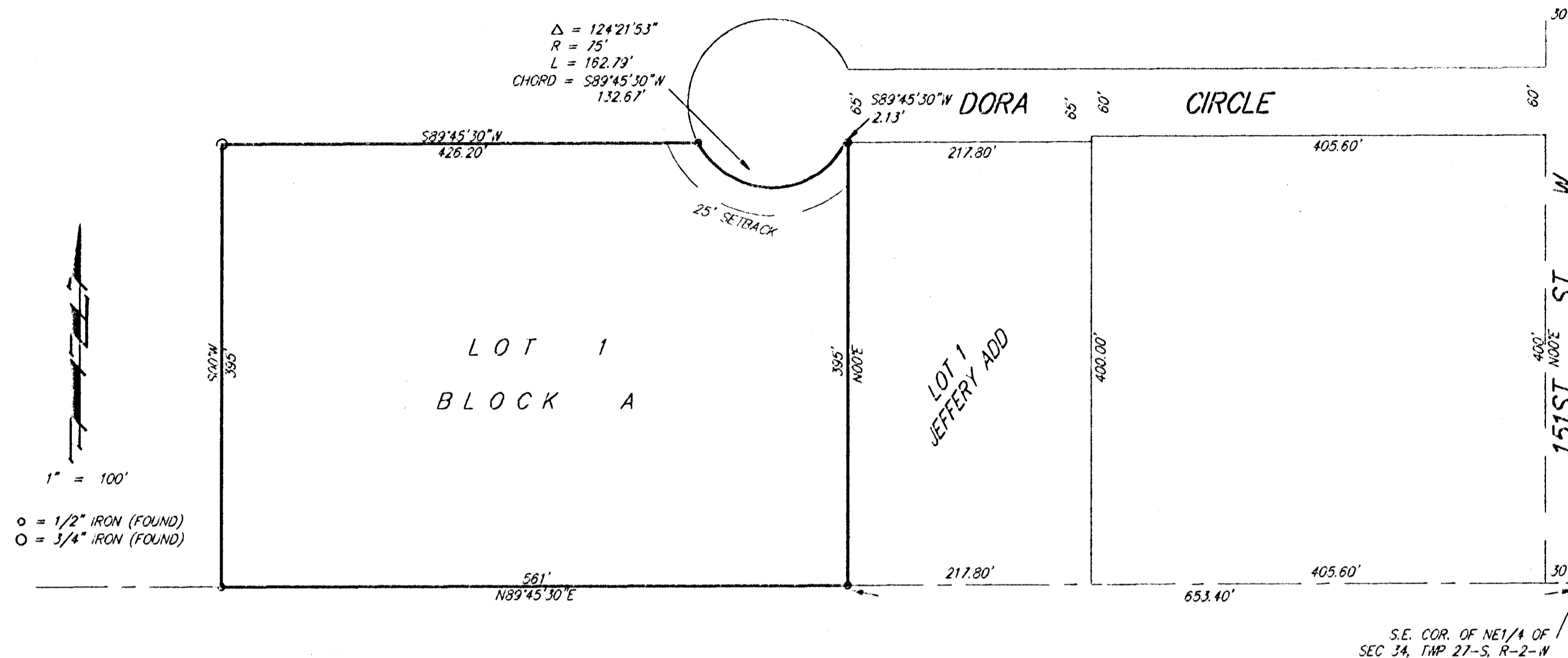

 accompanying plat is a true and correct exhibit of the property sur-
 veyed, described as follows:
 That part of the NE 1/4 of Sec. 34, Twp. 27-S, R-2-W of the 6th
 P.M., Sedgwick County, Kansas, described as commencing at the S.E.
 Corner of said NE 1/4; thence $S89^{\circ}45'30''W$, along the south line of
 said NE 1/4, 653.4 feet to the S.W. Corner of Lot 1, Jeffery Addition,
 Sedgwick County, Kansas, for a place of beginning; thence $N00^{\circ}E$,
 along the west line of said Lot 1, 395 feet to the N.W. Corner of
 said Lot 1; thence $S89^{\circ}45'30''W$, along the south line of Dora St. as
 platted in said Jeffery Addition, 2.13 feet to the P.C. of a Cul-De-Sac,
 having a radius of 75 feet; thence southwesterly, westerly and north-
 westerly, along said Cul-De-Sac, through a central angle of $124^{\circ}21'53''$,
 an arc distance of 162.79' (having a chord bearing $S89^{\circ}45'30''W$, 132.67'
 feet thence $S89^{\circ}45'30''W$, 426.20 feet; thence $S00^{\circ}W$, 395 feet
 to the south line of said NE 1/4; thence $N89^{\circ}45'30''E$, along the south

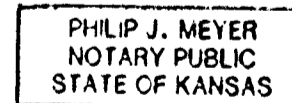
