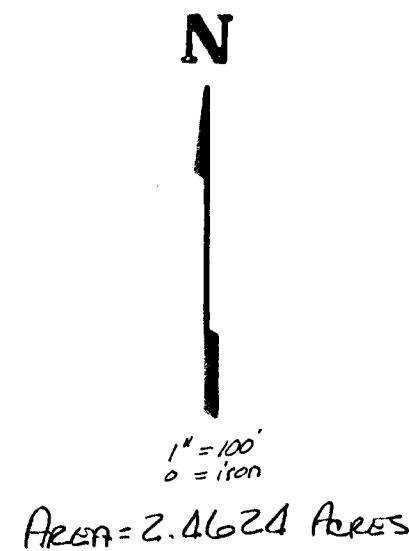
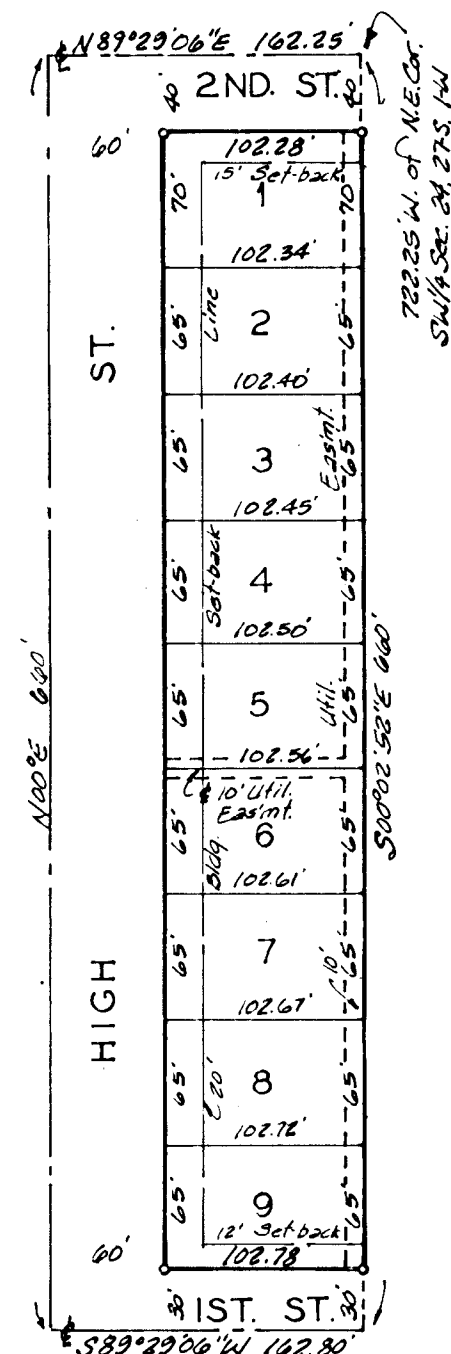


BADER 3RD. ADDITION
