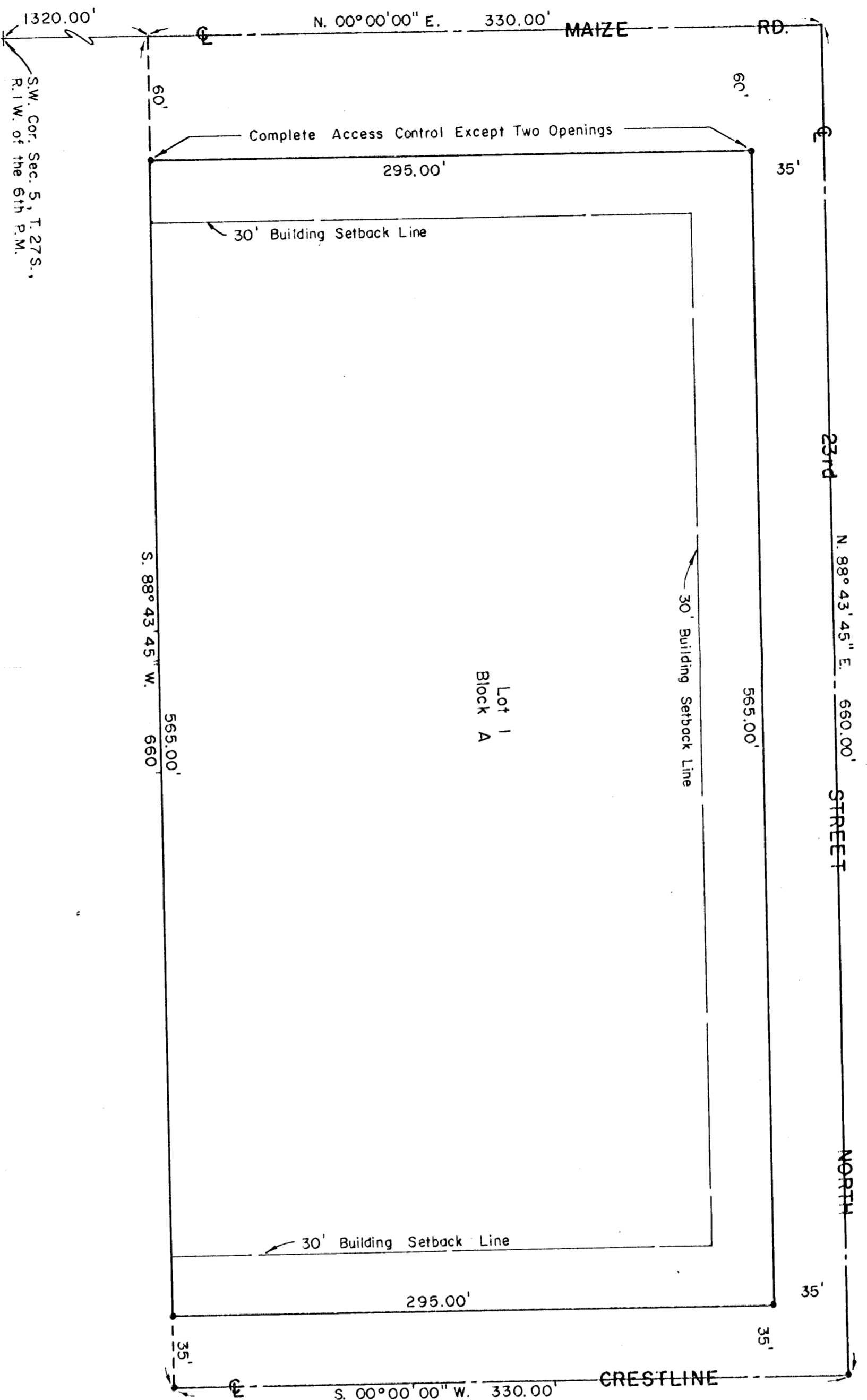


**AGAPÉ ADDITION
