



GENERAL PROVISIONS

1. This project is proposed to contain 527.7 gross acres. The area to be used as follows:

Building area	185.5
Net area	305.5
Public Streets	491.0
Total area	527.7

The proposed development, as illustrated, is to contain the following types of housing. The illustrated housing type for each parcel is enclosed in a box, (example 4-Plex) in the parcel description.

520 Single Family Units
52 Zero Lot Line Units
268 2-Plex Units
140 4-Plex Units
411 Townhouse Units
540 Garden Apartments Units
1905 Total Dwelling Units (Illustrated)

Note: E. Optional building types as described under specific parcel information below will increase this count and will not exceed the maximum overall net density requested under paragraph 3 below. The maximum number of dwelling units permitted is 2972.

3. Net Density Calculation: If the parcels are developed with the number and type of units illustrated, the overall density of the site, including the golf course, less public streets, would be 3.88 DU/Net acre, if the site was developed with the maximum number of dwelling units permitted, the overall density would be 5.44 DU/Net acre.

4. Setback shall be determined at time of platting depending on land use or generally the minimum setbacks shall be as follows:

5. All utilities shall be installed underground.

6. Signs designating the name of the development shall be permitted at the entrance to the proposed parcels if they follow the provisions of Section 20.04.129 of the City of Tallgrass. A homeowners association shall be established with the plat of each parcel to provide for maintenance of non-public open space, parking areas, streets or drives, buffer areas, drainage channels, swales, etc. Two or more of the homeowner associations may join together to form a master homeowners association.

8. Parcel 14 represents the general open space/golf course development and shall be operated and maintained by the golf course ownership. This site does not prohibit a master association of all homeowners from all parcels participating in the maintenance of the golf course. The maintenance of the general open space/golf course development including the clubhouse and related recreational facilities represent 186.5 acres or 35% of the total site.
