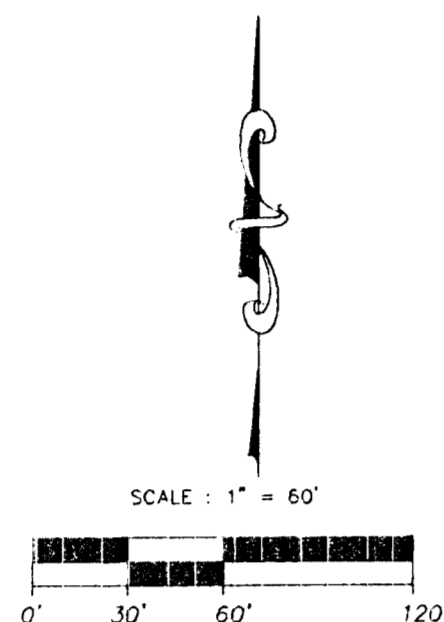


# WACO TOWNSHIP ADDITION IN SEDGWICK COUNTY, KANSAS



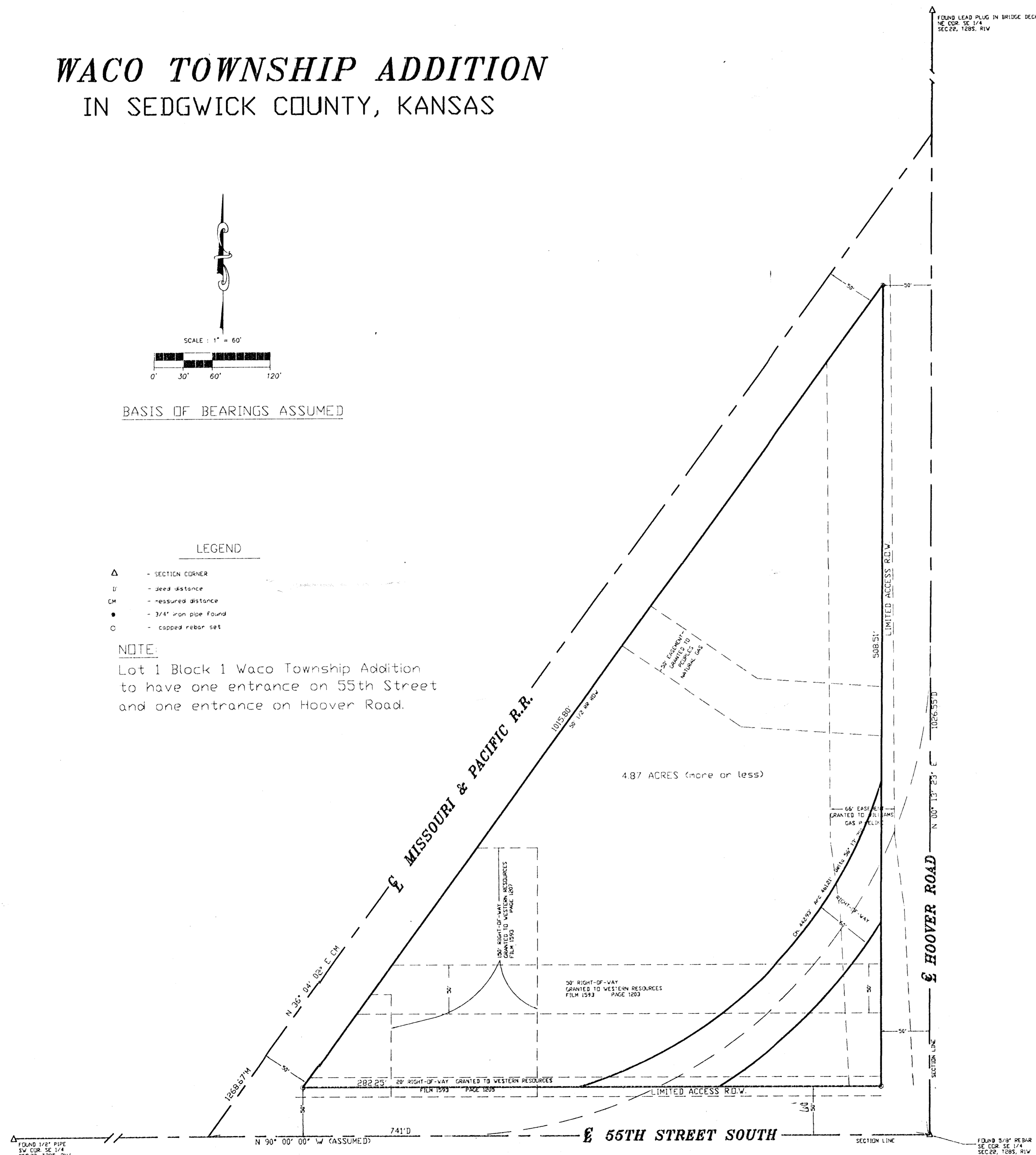
BASIS OF BEARINGS ASSUMED
