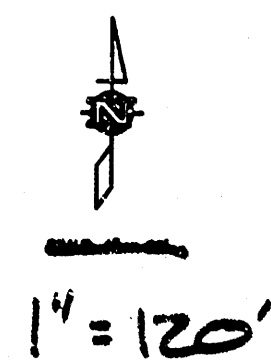


DRAINAGE PLAN

I, the undersigned licensed land surveyor in aforesaid county and state, do hereby certify that, under the supervision of the undersigned, we have surveyed and plotted "WILLOWBEND OFFICE CENTER ADDITION", Wichita, Sedgwick County, Kansas and that the accompanying plot is a true and correct exhibit of the property surveyed, described as follows:

A tract of land lying in the Northwest Quarter of Section 26, Township 26 South, Range 2 East of the Sixth Principal Meridian, Sedgwick County, Kansas, more particularly described as follows: Commencing at the Southeast corner of said Northwest Quarter; thence S89°10'08"W, 20.00 feet along the South line of said Northwest Quarter; thence N00°49'16"E, 1825.00 feet, parallel with the East line of said Northwest Quarter to a Point of Beginning; said point being a point on a curve to the left, thence along said curve 897.25 feet, said curve having a central angle of 89°10'08", a radius of 567.15 feet, and a long chord of 795.50 feet, bearing N45°38'17"W, thence S89°32'42"W, 662.84 feet, thence S78°21'48"W, 18.50 feet to the Southern right-of-way line of Missouri Pacific Railroad; thence N01°01'20"E, 497.70 feet along said Southern line to a point lying 35.00 feet south of the North line of said Northwest Quarter; thence N89°33'23"E, 824.88 feet, parallel with said North line, to a point on the East line of said Northwest Quarter; thence S00°49'16"E, 752.07 feet along said East line; thence S89°10'44"W, 20 feet to the Point of Beginning.

All being situated in Sec. 26, Twp. 26-S, R-2-E, of the 6th P.M., Sedgwick County, Kansas.

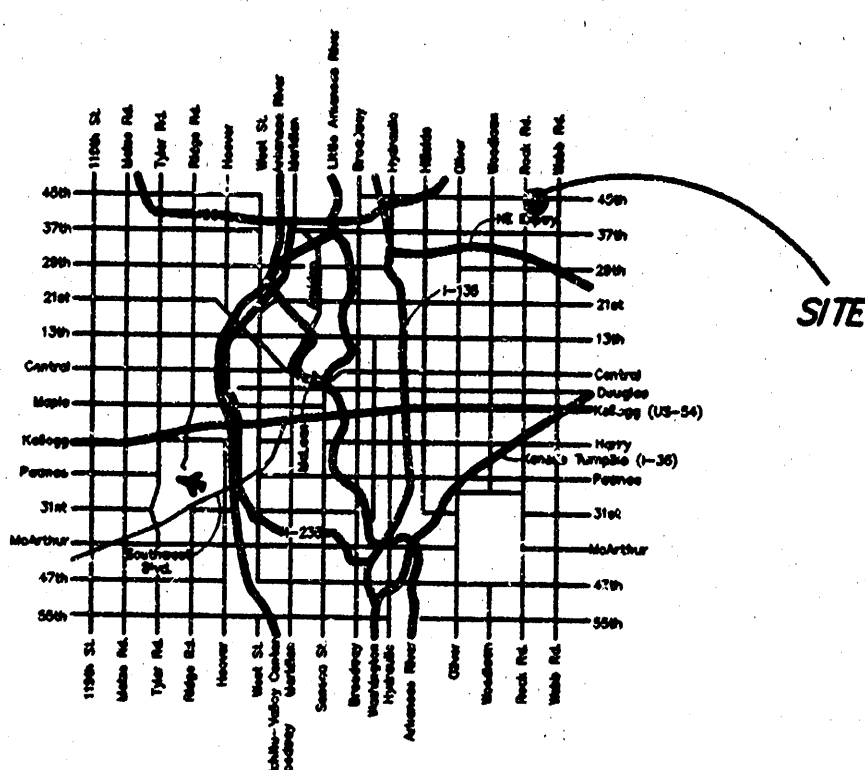
