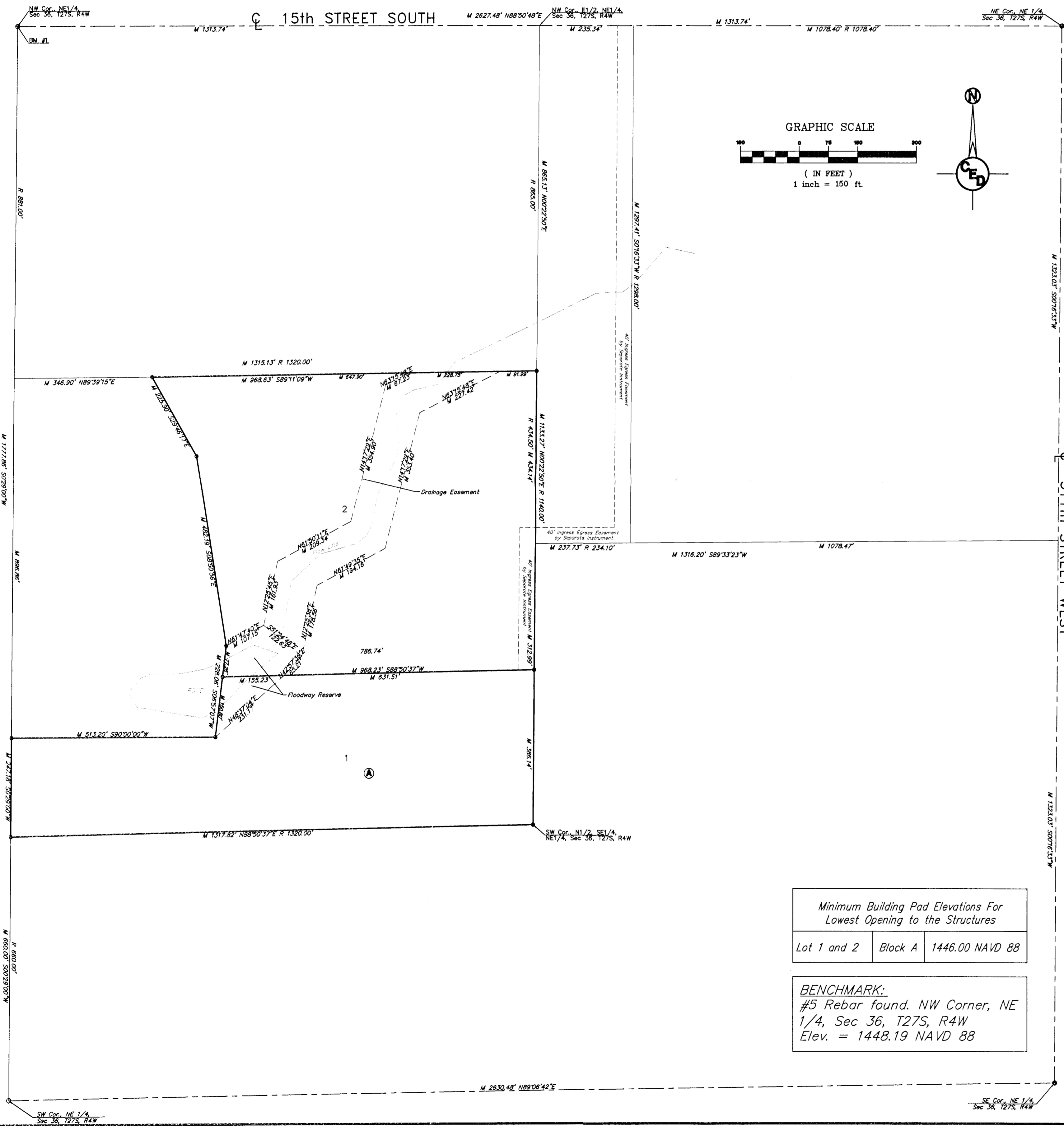

That part of the Northeast Quarter (NE1/4) of Section 36, T27S, R4W of the 6th P.M., Sedgwick County, Kansas, described as follows: Commencing at the NW Corner of said NE1/4, Thence S02°29'00"W along the West line of said NE1/4, 1777.86 feet for a Point of Beginning; Thence S02°29'00"W continuing along said West line, 247.18 feet to a point 660 feet North of the SW Corner of said NE1/4; Thence N88°50'37"E, 1317.82 feet to the SW Corner of the North Half of the SE1/4 of said NE1/4; Thence N0°22'50"E along West line of said SE1/4 of NE1/4, 1133.27 feet; Thence S89°11'09"W, 968.63 feet; Thence S29°46'17"E, 225.90 feet; Thence S8°50'56"E, 482.19 feet; Thence S6°57'07"W, 228.06 feet; Thence S90°00'00"W, 513.20 feet to the Point of Beginning subject to easements of record containing 24.37 acres more or less.

Know all men by these presents that We, the undersigned, have caused the land described in the surveyors certificate to be surveyed and platted into Lots, Block and Floodway Reserve to be known as "PANEK-DURHAM ADDITION" to Sedgwick County, Kansas. The Floodway Reserve is hereby reserved for floodway reserve purposes and shall be the responsibility of the owners of Lot 1 and Lot 2, Block A, "PANEK-DURHAM ADDITION", Sedgwick County, Kansas, until such a time as the appropriate governing body elects to assume the responsibility for maintenance and improvements to drainage. No buildings shall be constructed or placed on or within said Floodway Reserve. There shall not be any fill, change of grade, creation of channel, or any other work carried on in said Floodway Reserve without the permission of the Engineer for said appropriate governing body. The Drainage easement is hereby granted as indicated for drainage purposes. A drainage plan has been developed for this plat and all drainage easements and rights-of-way shall remain at established grades or modified with the approval of the Engineer of the appropriate governing body, and unobstructed to allow for the conveyance of stormwater. Minimum Building Pad Elevations for the lowest opening to the structures shall be as indicated on the face of the plat.
