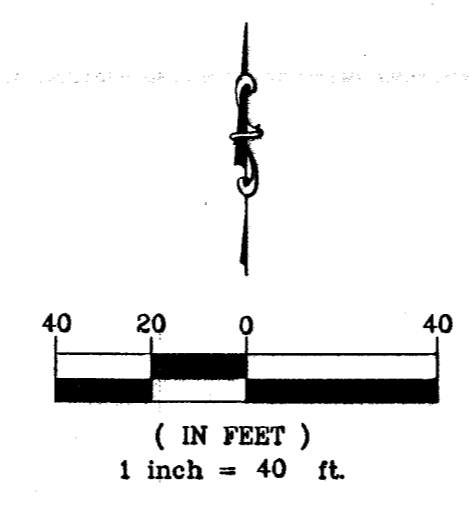
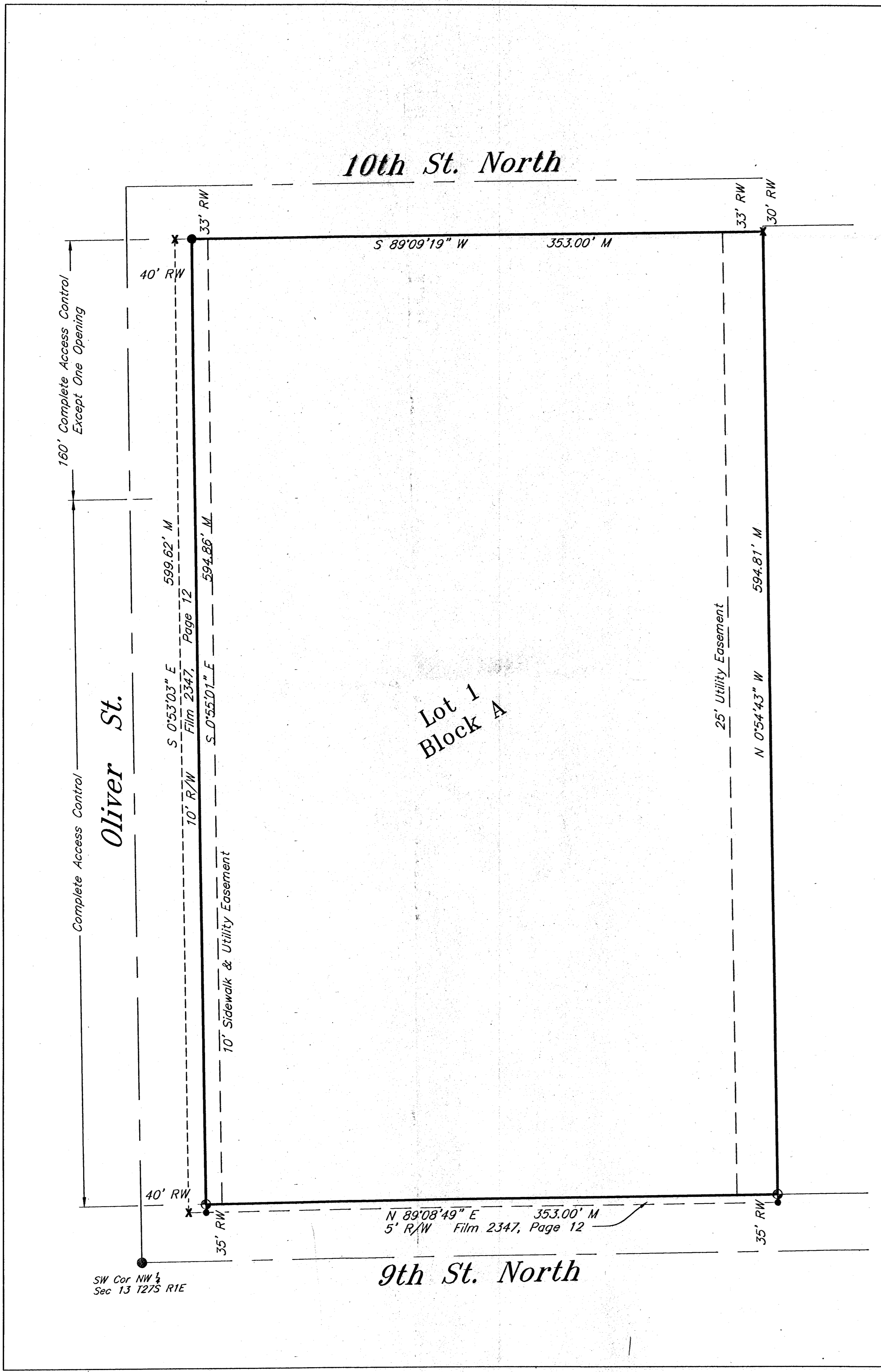


Adams Elementary School Addition Wichita, Sedgwick County, Kansas

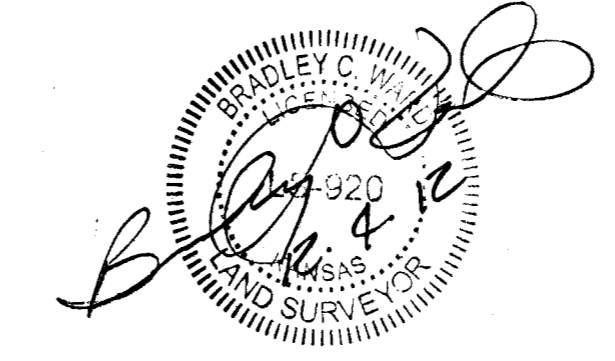

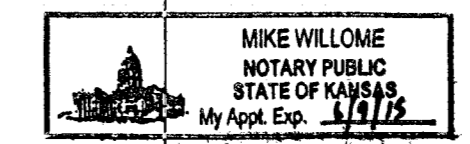
