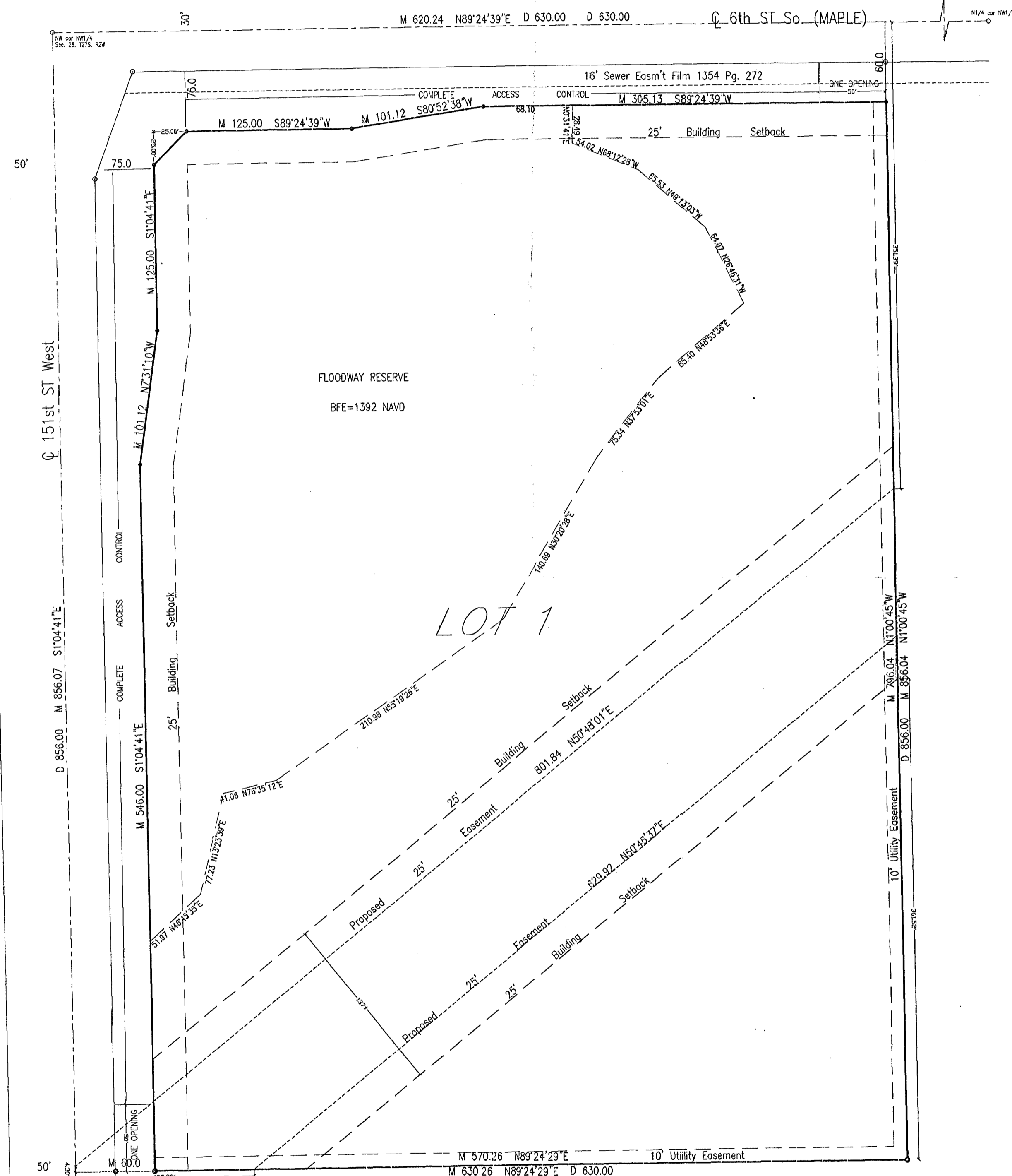
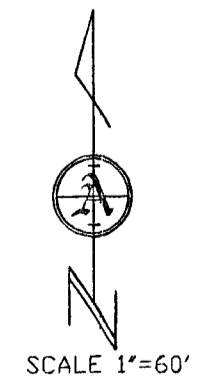


# FAWSON ACRES ADDITION
