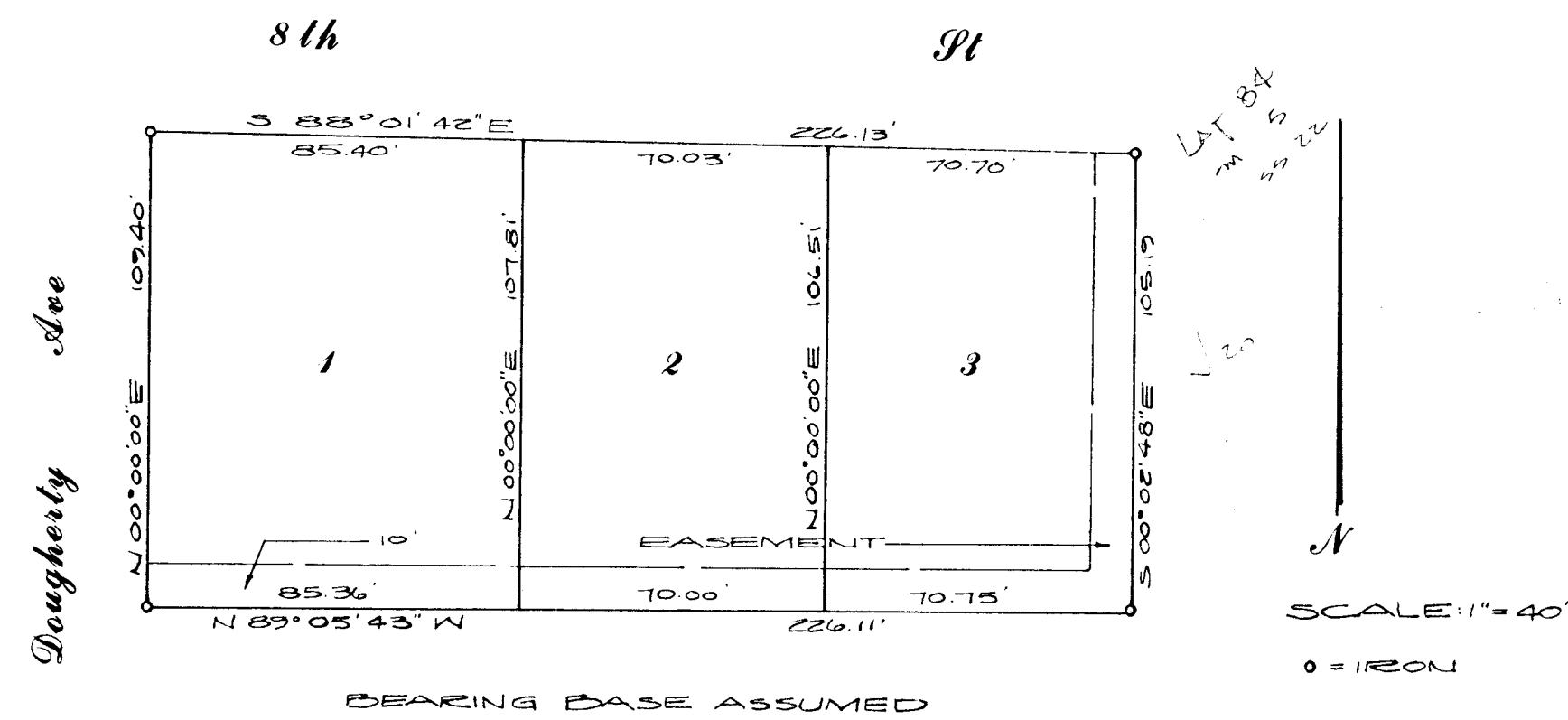


Carol Jean Addition to Wichita, Sedgwick County, Kansas.
