

 ADDITION," Wichita, Kansas and that the accompany-  
 ing plat is a true and correct exhibit of the prop-  
 erty surveyed described as a tract in the N.E. 1/4  
 of Sec. 15, Twp. 27-S., R. 1-W. of the 6th P.M., Sedg-  
 wick County, Kansas, commencing at the N.W.  
 corner of said N.E. 1/4; thence south along the  
 west line of said N.E. 1/4, 1832 feet; thence east  
 parallel with the north line of said N.E. 1/4, 30  
 feet for a place of beginning; thence continuing  
 east parallel with the north line of said N.E. 1/4,  
 132 feet south of the north line of said N.E. 1/4; thence  
 west parallel with the north line of said N.E. 1/4 to  
 a point 30 feet east of the west line of said N.E. 1/4;
