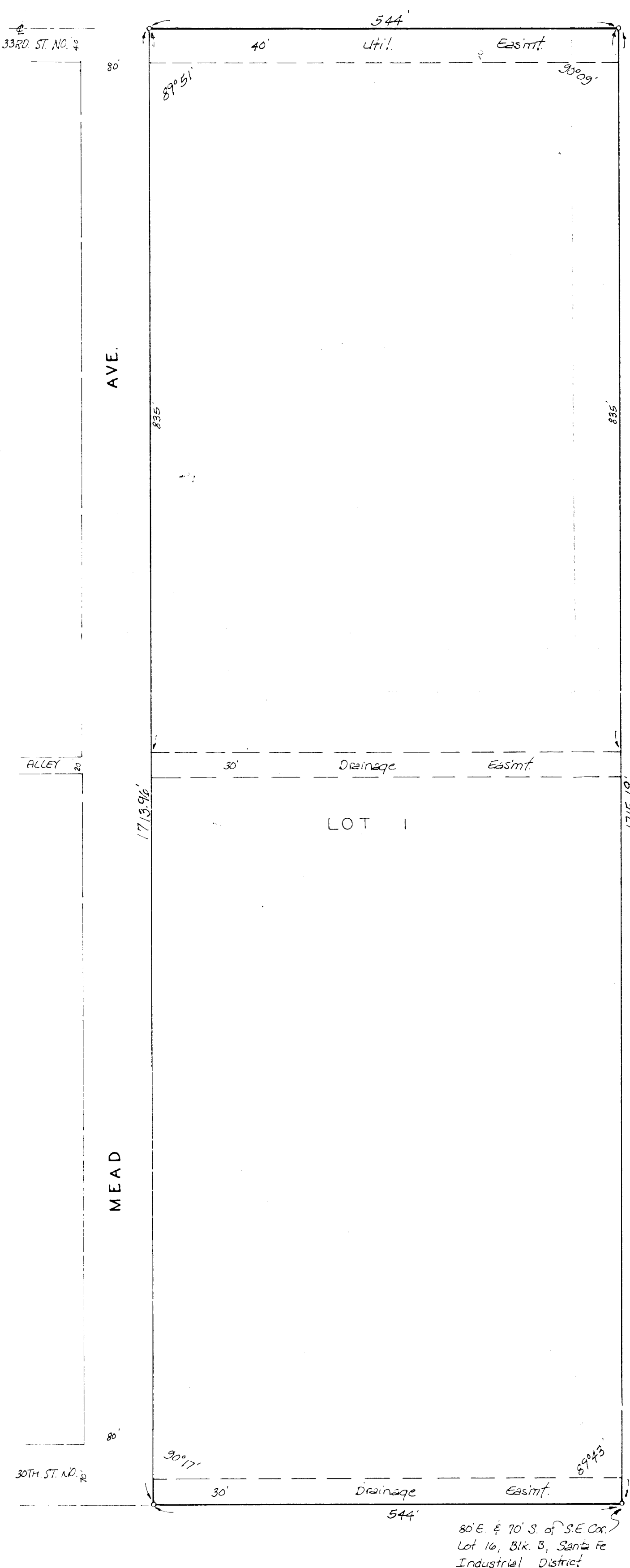


COLEMAN CO. ADDITION

ADDITION" Wichita, Kansas and that the accompanying plat is a true and correct exhibit of the property surveyed, described as and being a replat of Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, and 18, Block B, Santa Fe Industrial District of Wichita, Kansas, together with all of the Alley lying between said lots 7, 8, 9, 10, and together with part of 33rd St. No., part of 30th St. No. and all of Mosley Ave., being more particularly described as beginning at the N.W. corner of said Lot 1; thence north along the extended west line of said Block B, 40 feet to the north line of 33rd St. No. as platted in said Addition (being the north line of the SW 1/4 of Sec. 33, Twp. 26-S, R-1-E); thence east parallel with the north line of said Lots 1 and 2, 544 feet to the east line of Mosley Ave. as platted in said Addition; thence south along the east line of said Mosley Ave., 1715.19 feet to the south line of 30th St. No., as platted in said Addition; thence west along the south line of said 30th St. No., 544 feet to the west line of said Block B, extended south; thence north 1623.96 feet to the place of beginning, the streets and Alley being vacated by virtue of K.S.A. 1970 Supp. 12-542(b).
