 the undersigned, have caused the land described in the

 way, nor shall any fill, change of grade, creation of channel
 or other work be carried on without the permission of the
 Wichita-Sedgwick County Flood Control Office or their suc-
 cessors of office. The street is hereby dedicated to and for
 the use of the public. All abutters rights of access to and from
 6th St. So. over and across the north line of Lots 1 and 2 are
 hereby granted to the county; provided however that Lots 1 and 2
 shall have access to 6th St. So. at two points per lot, all as
 shall be determined by the County Engineer.

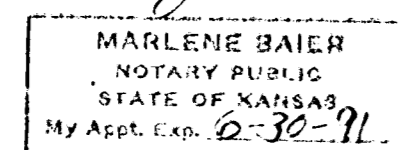
